Betsy Ross Road/Garfield Lane road vacation. Kilgore reported that the road was recorded and we will need to follow the MN statutes for vacating it. We can get the approval by the voters at the annual meeting. Diedrich instructed Kilgore to write letters to the property owners that will be effected by the road vacation.

Way made the motion to adopt Resolution 21-06 requesting the County Assessor to reinstate the Local Board of Equalization & Appeal Powers to the Ida Township Board. Diedrich seconded the motion.
