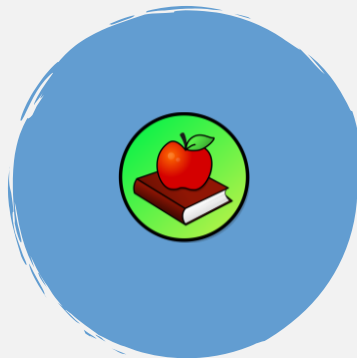

Triumph sprang into action to ensure children, families & staff were supported during this time.

WHAT HAVE WE BEEN
UP TO SINCE MARCH?



- Set up and implemented virtual learning for all families—75% participation rate!
- Virtual ‘moving up’ and ‘drive-by’ celebrations
- Kindergarten transition meeting with public schools
- Materials purchased and distributed or mailed for 300+ children
- ASQ-SE mailed to families
- Continued Referrals to Early Intervention
- Referred families to Mental Health Consultants
- Provided mental health support services for staff
- Collected & Delivered goods and checked in with families
- Coordinated “well checks” for families that we were unable to contact
- FaceTime sessions with families
- Buildings were cleaned and sanitized
- Paintings of most classrooms

- Continued Manager’s Meetings & content area meetings & supervisions
- Conducted virtual Board of Directors and Policy Council Meetings
- Wrote and submitted grants; Closed out reporting for year end for state grants.
- Wrote and submitted community grants to BCSB, South County Emergency Fund, Eastern Bank and City of Taunton
- Participated in webinars, trainings and meetings online
- Created Annual Report and updated community assessment
- Began preparation for Audit & Agency Budget
- Updated Parent and Staff Handbooks; Updated procedures in line with new EEC regulations
- Facebook, Instagram & Websites updated regularly
- Tracking COVID among staff and families
- Processed COLA and retro pay
- Processed and tracked hundreds of purchases & paid invoices

New Classroom Format & Times

- EEC has altered the number of children allowed in the classrooms and total capacities, and allows for shorter days for children to allow for new cleaning regulations and limit exposure. This will remain in place until September (at a minimum)
- The Governor has restricted the capacity for the number of adults per office
- Triumph will slowly and methodically introduce children back into the program

New Temporary Start and End Times:

Center Based Children: 8:00 am to 2:00 pm

Full Day Children: 9:00 am to 4:00 pm

Children will be dropped off at 15 minute intervals at the front door. (Exact Procedure to follow)

No transportation until regulations for social distancing have been lifted

New Time Line For Return—Virtual Teaching & Training will continue for Preschool through August 7

June 29-July 2	Some Office Staff return on a staggered schedule	
July 6-10	EHS staff return to begin classroom prep and to begin scheduling home visits—Virtual Learning Continues for Full Day Head Start and Home Based	
July 13-17	All EHS Education working & doing home visits	
July 20-24	EHS Full Day Children Return	
July 27-31	All EHS Center Based Return; HS and Home Based staff return to begin classroom prep and schedule home visits (in-person)	
August 3-7	HS Staff begin home visits	
August 10	Full Day Preschool begins	
September 7 & 8	Parent Child Days for CB Head Start Full day, etc. still attending	
September 9	First day of new school year	

New procedures for drop off and pick up

Pre-Health Check

- Parents and Caregivers will be required to complete a daily health check before leaving home
- Procedures & Requirements outlined in Parent Handbook
- If you answer “yes” to anything on the health check, your child may not attend school
- Please call the front desk to report the absence



Drop off and Pick Up Times

- Parents and Caregivers are not allowed in the buildings
- All families will receive a designated drop off and pick up time in 15 minute intervals according to their classroom. Siblings may be dropped off together
- This is very important to adhere to so that we can maintain social distancing regulations regarding the least amount of contact
- If you are late for your drop off and pick up time, your child cannot come to school



Arrival and Departure Procedures

- You will receive a “car tag” with your child’s name and classroom
- Caregivers will arrive and park their cars
- Bring the car tag and your child to the designated health screening spot
- A health screening will be conducted. Once screened, you will verify the results with your signature, and sign your child in. A staff member will escort your child to their classroom
- At pick up, you will park, bring your tag, and a staff member will retrieve your child

What are you doing to keep my child safe?

Staff

- ✓ Health screenings before entrance
- ✓ Extensive training on new procedures
- ✓ PPE's provided
- ✓ Strict sick policies and travel restrictions
- ✓ 3 staff in each room to help with cleaning & sanitizing protocols
- ✓ Minimum amount of "other" staff in the buildings

Families

- ✓ Pre-checks before leaving house
- ✓ Restrictions on adults in building
- ✓ Virtual meetings and trainings
- ✓ All parents must sign off on new policies

Physical Environment

- ✓ Health Screenings
- ✓ Lower Staff Ratios
- ✓ No mixing of groups of children
- ✓ Less toys and materials
- ✓ Assigned staff—with masks
- ✓ Assigned outdoor times
- ✓ Removal of rugs and soft toys

POTTY TRAINING IN THE TIME OF COVID

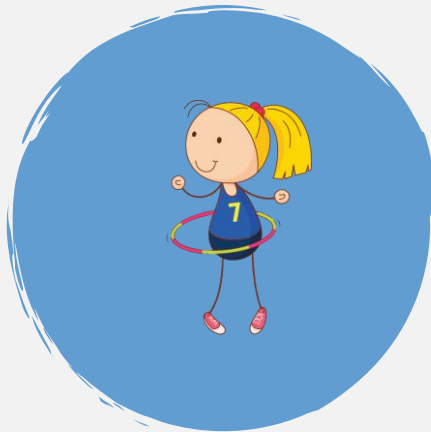

We may have to limit the number of children in preschool rooms who are not trained due to strict new diapering and cleaning requirements.





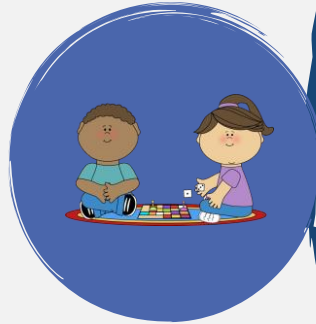
Individual Learning

Individual learning kits with crayons, markers, scissors, etc. will be given to each child so they don't have to share



Outside Time

A lot of time will be spent outdoors using individual items, hula hoops, bubbles, balance beams, etc.



Small Groups

Children will be allowed to play with 1 other child in the centers

The office of Head Start and the EEC payment system is offering many flexibilities regarding enrollment and payments



HEAD START



As long as you fill out the questionnaire required by EEC, and/or speak to your FES or ERSEA office, we can offer you flexible start dates. You must be open to virtual learning while not attending ‘class’.

- Do not bring your child to school if they are sick
- Parents, guests, consultants, EI and therapists are not allowed in building at this time
- Sticking to your kids' schedules is imperative
- Drop off times are very specific to avoid mixing groups
- Snacks & Meals will not be Family Style
- Field Trips are cancelled
- Self screenings must be done before leaving home, and will be repeated upon arrival
- If your child gets sick, they will be isolated until you arrive. Please come **asap**


Non-Negotiables
