The waters of the flood followed the path of least resistance, emptying themselves into the basin known as the Gulf of Mexico. When the Western Interior Seaway completely dried up, it left in its wake massive sedimentary fossil beds

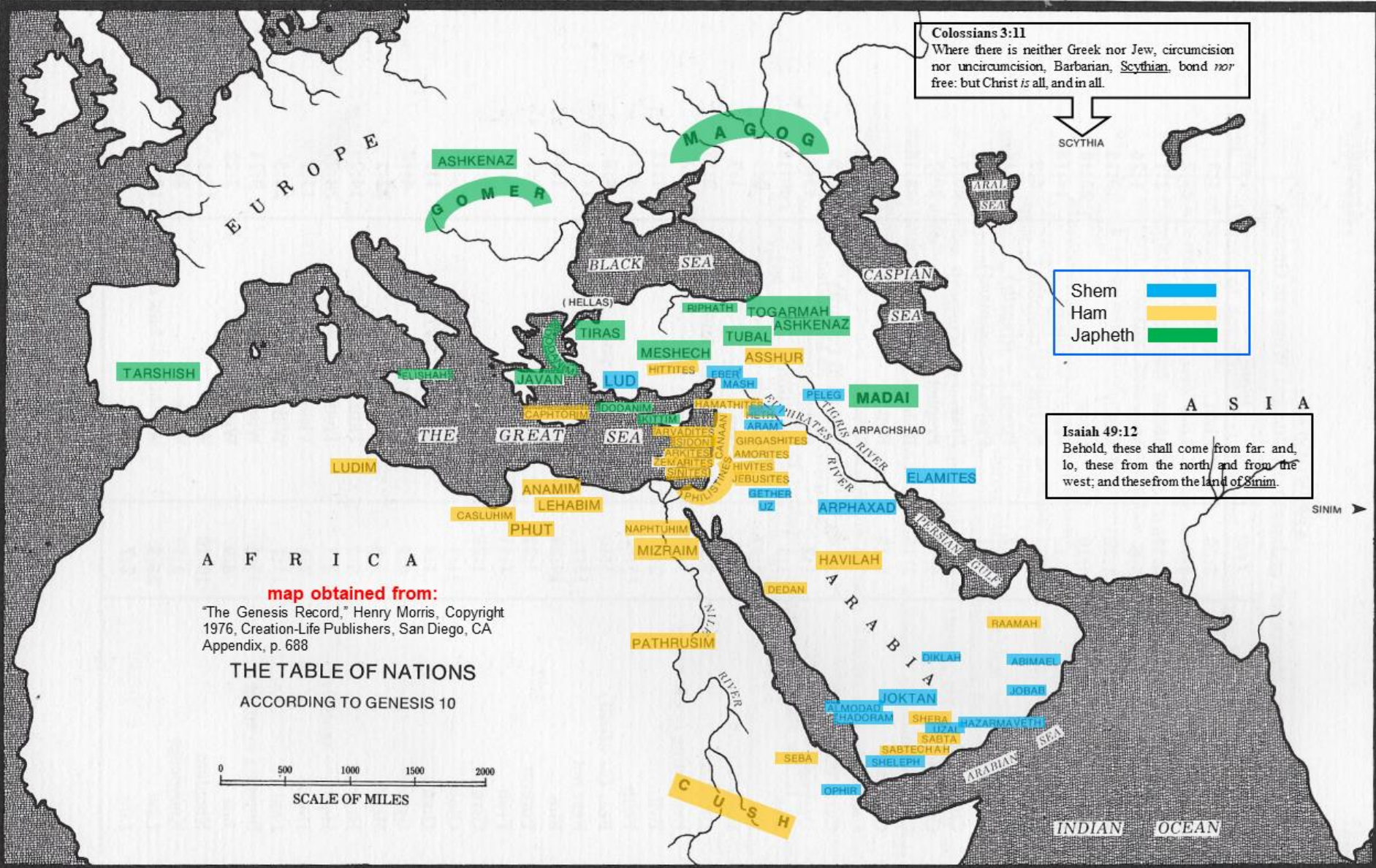

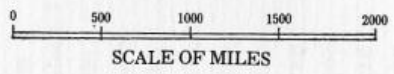

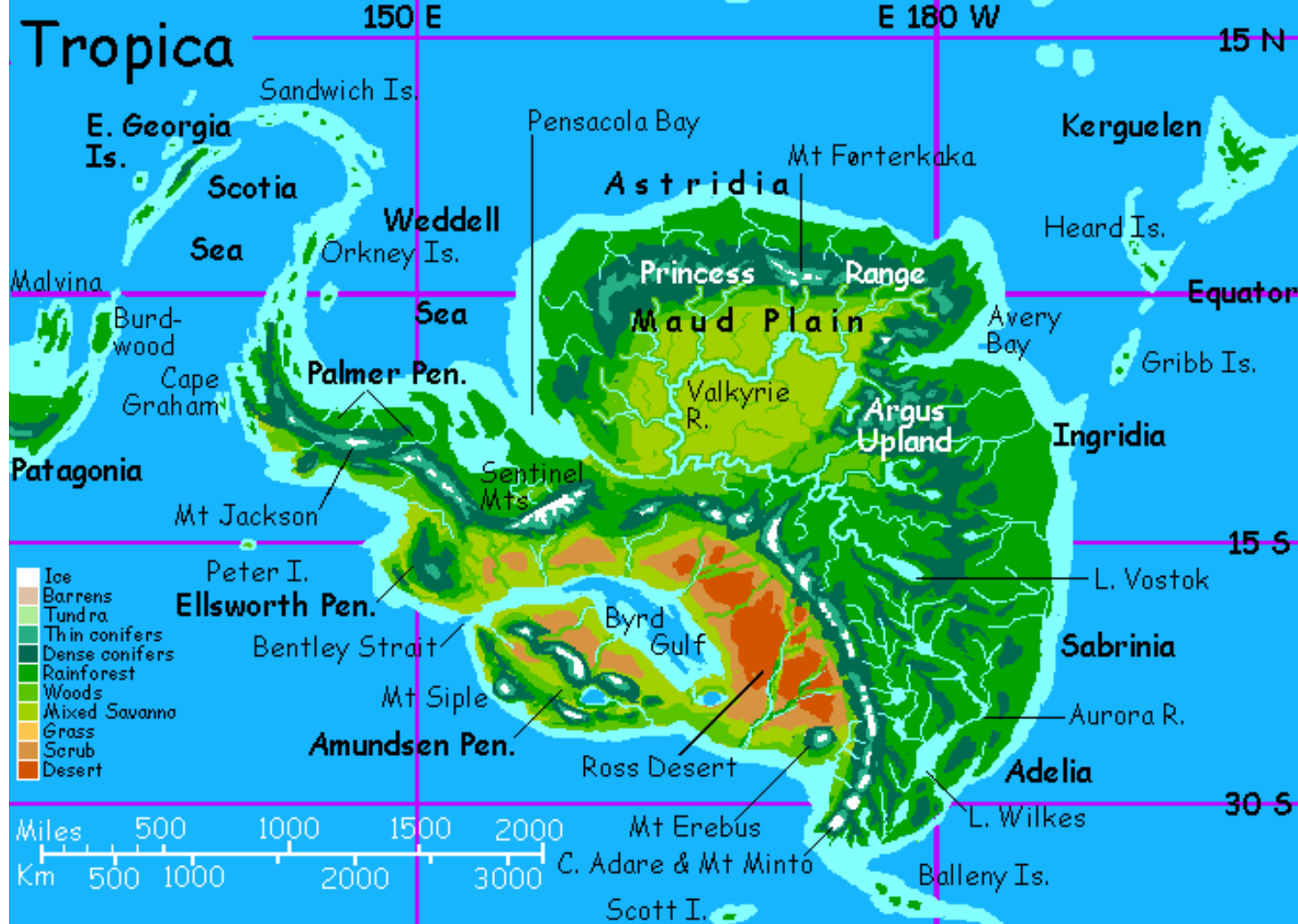
THE TABLE OF NATIONS

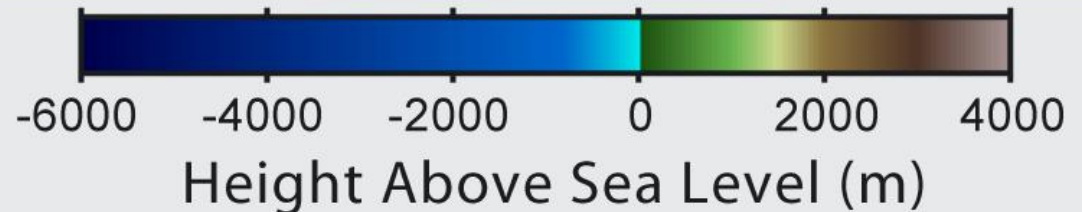
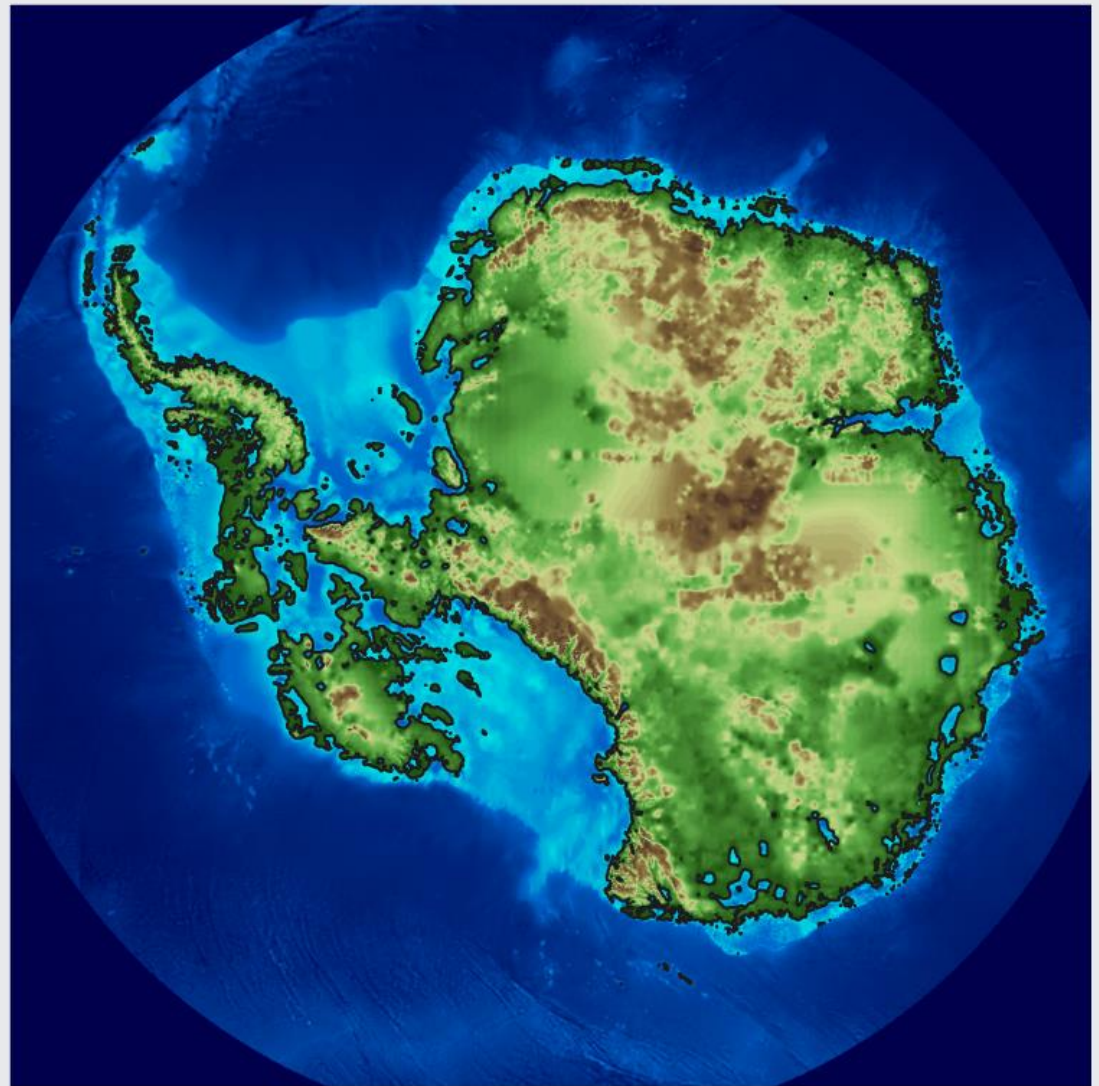


This map of Antarctica reveals a continent whose places and names have been constructed from previous source maps (Piri Reis), showing the island of Tropica during its appearance before the world-wide flood of Noah. It should be noted there were no deserts prior to the flood. No other land mass saw the consequences of a global climatic upheaval as much as this secluded island oasis experienced. A land inhabited by antediluvian peoples whose existence was completely erased in the blink of an eye,¹ this remote island witnessed a dramatic change in the earth's subsequent climatic variability produced by a 23.5° tilt of the earth's axis from its heretofore perpendicular angle to the ecliptic. This continent was unique in what happened to it after the antediluvian climate changed, planetary flood waters receded, and the tilt of the axis created six months of daylight and six months of darkness in the polar regions. This gave rise to a phenomenon distinct from that of the pre-flood world, seasonality. This seasonality eventually gave way to an overall global event known as the Ice Age.

1. This was literally true for we have mammoths quick-frozen in the northern tundra of Siberia, polystraited fossils (a fossilized tree passing through many layers, representing supposed long ages, already petrified) appearing through many strata of laid-down sediment, 'calculated' to be millions of years old. There are also marine fossils of fish, frozen in a moment of time, as they are about to consume a meal, or with its meal evident from the stomach contents still visible through a phenomenon known as fossilization.

Deglaciated Antarctic Topography

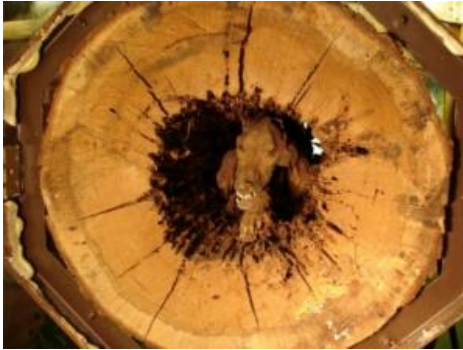
A topographical map of Antarctica with a rebounding of the land after the ice has been removed, along with a corresponding rise in ocean levels having been accounted for.





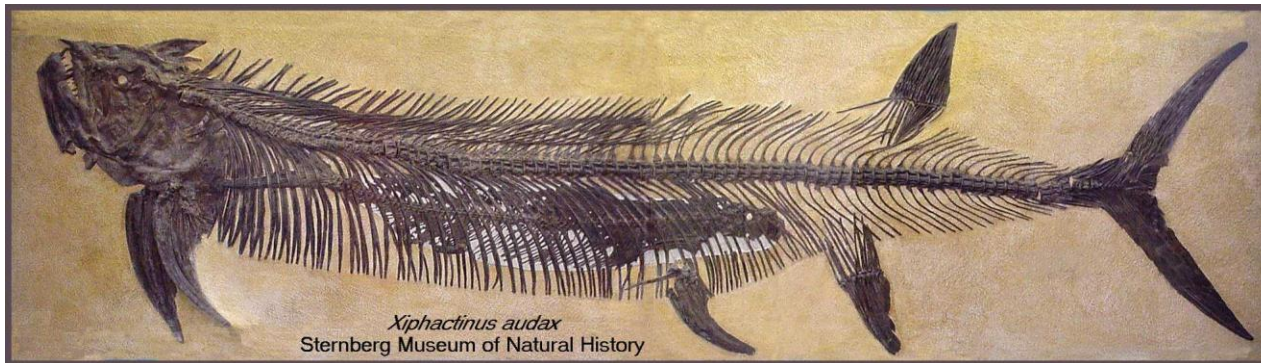
