
### 2. RELIGIOUS COLLECTIVISM

Religious collectivism is the primary vehicle through which men will ultimately 'conquer' the seed of the woman (Christian, freedom-loving people). The lie all collectivists teach is the individual is subject to the group or collective memory complex, namely the masses controlled by the tyrant. Religious collectivism has perverted governments and produced policies which can be summed up in the phrases, 'the end justifies the means,' (murder; Agenda 2030) and "reaching across the aisle" (two steps forward, one step backward). Currently the Deep State has co-opted and corrupted virtually every business, corporation, Hollywood agent and actor/actress, government entity, major league sports franchise, tradition and institution in America

#### 3. HATRED OF THE SEED OF THE SERPENT TOWARD THE SEED OF THE WOMAN

First evident in Genesis 3, sin with its independent mindset free of God's influence, instruction, and love Adam and Eve's rebellion produced death, the curse, and destruction on a scale unimaginable. We are told from Genesis 3 that those coming from our first parents fell into two camps, namely those that follow Jesus Christ and those that follow themselves and Satan. From Eden, the seed of the serpent and the seed of the woman, with their allegiances and alliances, become increasingly more apparent and distinguishable. In Genesis 4 we witnessed the murderous, unrepentant line of Cain whose generational hatred is evident. It is not until the birth of Seth's offspring, Enos, that men began to call upon the name of the LORD (Gen. 4:26). In Genesis 5, it was Seth's offspring known as the sons of God, that carried on the torch of the primitive patriarchal faith of Adam to the generation of Noah. In Genesis 6:2 the sons of God compromised their faith looking on the daughters of men only as flesh to be exploited, not as individuals of beauty in appearance as well women loving their Creator through their spirit. After the flood, the antichristian mindset was rebranded and re-packaged through a charismatic giant known as Nimrod—a mighty hunter before the LORD. Erecting a clandestine monolith known as the Chaldean Mysteries, Nimrod's subversive movement called itself 'Christian.' It is a system the Lord warned his followers about in the book of Revelation. Its surrogates, operatives, and assets are religious in appearance and are the direct descendants of the seed of the serpent, whose followers are clothed in the clerical garb of Romanism, and its corrupt offspring Protestantism. It is these individuals and these movements Jesus identifies as MYSTERY, BABYLON THE GREAT, THE MOTHER OF HARLOTS AND ABOMINATIONS OF THE EARTH. It is this religious system that prowls today seeking whom it may devour.

Taking the largest of the two archeological excavation sites (A & B), the Ziggurat of Jiroft in the southern Iranian Province of Kerman, largest ancient ziggurat discovered to date is 13.5 hectares (1,453,127.91°) at its base and 61m (200') in height. Given the age of the structure (Genesis 11:1-9 [1,723-1,733 B.C.]), change in climate shortly after the global flood of Noah, the construction practice of building on top of previously destroyed edifices, wind erosion, as well as the destructive nature of subsequent empires, it is safe to assume that this ziggurat could have at one time reached 4,359,383.72° at its base, while the height could have been as much 8,000' high. Contemporary height measurements place this ziggurat at 200'. This is far less than the 20' the religious shrine could have stood (20³ being 8,000'). Why would this be so difficult to conceive considering the tallest building in the world is Burj Khalifa at 2,722' high. Look at the dimension of Noah's ark with just 8 people working on it for 100 years. The Book of Jasher states in 9:38 that after God's judgment only one-third of the ziggurat was visible. It also mentions in 9:23 that the labor force was 600,000 men. Give 600,000 men 10-12 years to construct a city and a tower . . . And well, you could only imagine what could be built!
