

Meeting Schedule. We have maintained the changes to the meeting schedule established in 2023. We expanded the in-person meetings from quarterly to bi-monthly. - O Thank you to the many individuals who play important roles in the Church whether it is serving on a committee/task force, offering a ride, offering a prayer, greeter, ushering, acolytes, choir and band members. ANNUAL REPORT FROM THE PASTOR FOR 2024

INTRODUCTION

2024 was a year of vibrant ministry for our congregation. *Some of the story is told through numbers*: we received 12 new members, baptized 4 children and 1 adult, and confirmed 3 teens. We again placed 1st in our Synod for giving to the ELCA World Hunger Appeal per confirmed members, and so again won the Holy Cow! Look What We Did For World Hunger! Award. *Some of the story is told through what is new*: a new mixed voice choir, JOYFUL, has begun, directed by new member, Patti Stoddard. We have upgraded audio-visual equipment and made changes in our Memorial Garden. Our website has been beautifully updated and changed. *Some of the story is told through what is ongoing*: our wide assortment of musical ensembles, fellowship and study opportunities, and community picnics and events have continued to gather people, old and new, together. Our Council has met monthly and has worked hard on our constitution and by-laws to do necessary updating. Our worship has remained a vibrant component of ministry, as we worship outside all summer long, feature so many styles of music within our worship all year, and provide the opportunity for people to worship from home through our live-streaming. Our average worship attendance was 65, the highest ever, indicative of the appeal of our efforts. This past year we have grieved some significant deaths and celebrated glad happenings together, demonstrating the value of being a part of this "heart of the community". God has been good to us!

HIGHLIGHTS OF EACH SEASONS

WINTER-

- *Our Annual Meeting was held, celebrating the previous year's ministry.
- *Reports were filed as required by our congregation for the Synod and Churchwide.
- *We celebrated the 100th birthday of our matriarch, Audrey Carlson, on February 18!
- * I took a month-long Sabbatical, focused on Biblical studies and dulcimer music. Members of the congregation filled in beautifully in every way imaginable.
- *Our new choir, JOYFUL, started up, led by Patti Stoddard.
- *The Lenten season began with Ash Wednesday worship and continued with Wednesday evening study led by Randi Alreck.

SPRING-

- * We performed 3 Holy Baptisms
- *We received 6 new members
- *We moved through the season of Lent into the observance of Holy Week and the celebration of Easter.
- * We recognized our graduating senior.
- *Church picnics started up at the end of May and were a great community gathering opportunity.
- *Our Synod Assembly was held. We again won the Holy Cow Award!
- *VBS happened June 10-12

SUMMER-

- *Worship moved outdoors, lots of good energy.
- *Our tech team (Scott Shelerud, Jim Allert, Phil Berge—thank them often and sincerely!) had new challenges to face to live stream outside.
- *3 of our young people were confirmed on June 30.
- *Church picnics continued through early fall and were very popular, bringing in community members as well as church members.
- *Special services included Bluegrass service, Gospel service, Blessing of the Animals

FALL-INTO DECEMBER

- *We worked on our patio to improve safety and accessibility.
- *We started up Children's Church and Kid's Connect, along with Confirmation.
- *Worship moved indoors, but attendance remained strong.
- *All of our musical ensembles started up.
- *6 new members were received.
- *We held a successful Fall Fun Fest.
- *Special services like All Saint's Day, Advent, Christmas were held.
- *Our Live Nativity at Julebyen was a wonderful and joyful retelling of the Nativity story.

OTHER ITEMS OF NOTE...

STEWARDSHIP

Once again, we had a strong year financially, essentially breaking even, remaining debt free, and gaining in our total means. Additionally, we supported numerous special offerings, especially around the Holidays (Elder Care Giving Tree, God's Barnyard, Red Bucket Salvation Army). To be able, in addition, to give so much away for outreach is truly commendable! Please see the stewardship report. Many, many thanks are due to Michael Dent and Ed Lee, our bookkeeper and treasurer! They do a tremendous job!

PASTORAL MINISTRY

Pastoral care is an aspect of ministry that I particularly find meaningful and satisfying; that's probably a good thing, as we have continued to have many needs for such care in our church and community. I made about 97 home/residence visits, 3 hospital visits, 25 extended phone calls, 56 brief indoor church visits. I had 15 pastoral care sessions. I performed 2 weddings, 5 baptisms, confirmed 3 students, celebrated First Communion with 4 students, and performed 3 funeral/memorial/graveside services, and we received 12 members.

MINISTRIES WITHIN THE COMMUNITY

The main vehicle for my pastoral involvement in the surrounding community is through the Two Harbors Ministerium. Typically, we provide ministry for the nursing homes, we sponsor community services each year, and we oversee the Neighbor to Neighbor Thrift Store.

MINISTRIES WITHIN THE CONFERENCE

Our conference is the Lake Superior Conference, stretching from Proctor/Duluth up to Grand Marais/Hovland. There are five such conferences within our Synod. Monthly meetings are held for pastors like myself to attend, which combine education with fellowship and support, most of them virtual this year. I attended just a few, because of schedule conflicts.

MINISTRIES WITHIN THE SYNOD

Each pastor in our Synod has obligations within our Synod. These include attending the Synod Assembly, attending conference and cluster meetings, and perhaps serving on special task forces. This last year, as in years past, I served on the Guidelines for Pastors and Lay Leaders task force. Our Synod also sponsors a spiritual growth group for clergy, Grounded in Grace, which meets monthly, of which I am a part. I attended the Synod Assembly as well.

CONTINUING EDUCATION/SABBATICAL

Each Pastor is encouraged to pursue Continuing Education each year. I attended weekly text study meetings, monthly Grounded in Grace meetings. And I was blest with a one-month sabbatical of Biblical study time!

MOVING INTO 2025.....

*My upcoming retirement on June 1 of this year means that the congregation will be entering a time of transition and visioning. Happily, we have excellent leadership, wonderful Synodical guidance, and we are in a strong position in most every way imaginable to work through this transition.

*I will be making sure records are in order and all is in place for whatever/whoever is up next.

*We will continue to explore the best avenues for ministries with children and teens, including our program year education programs and perhaps some kind of summer VBX experience.

*We will want to build upon our great foundation of community involvement with meals, picnics, and other events, so that we are utilizing our beautiful grounds, kitchen, and building for the good of our community.

IN CONCLUSION...

Once again, we may be grateful for all the ways God has blessed us to be a blessing; to live out our mission as the Heart of the Community!

The Mission Endowment Fund is intended to provide mission support beyond the congregation's operational budget with emphases on youth, education, and property/capital improvements. According to KRLC bylaws, only the interest earned from the principal can be spent.

In November of 2023, the Endowment Committee received one scholarship request. The Congregation Council approved the awarding of the scholarship on January 7, 2024, and it was disbursed accordingly. In 2024, the Endowment Committee received one scholarship request in late November. The Committee will consider and act on that request early in 2025.

The Committee reviewed fund investment options, meeting with Ted Bujold, Senior Portfolio Manager at RBC and current custodian of the fund; via telephone with Matt Wagner (Thrivent Charitable Giving) and Greg Hanson (Thrivent); and Zoom meeting with Tharan Lepold, Gift Planner with the ELCA Foundation Ministry. The decision was made to remain with RBC the current custodian of the fund, and to begin exploring Social Screened investments possibilities for those who might desire that option.

In response to the Congregation Council's initiative to revise and streamline the congregation's Bylaws, the Committee began working on revising the Bylaws governing the Endowment Fund. There is considerable work still to do on revisions. One important step in moving forward with the work of bylaw revision would be an amendment to the KRLC Constitution.

Proposed Amendment:

C5.05. This congregation shall have a mission endowment fund that will operate as specified in this congregation's bylaws and continuing resolutions. The purpose of the mission endowment fund is to provide for mission work beyond the operational budget of this congregation.

This amendment was approved by the Congregation Council and will be voted on at the KRLC Annual Meeting on February 9, 2025.

ENDOWMENT COMMITTEE REPORT FOR 2024 (continued)

In 2025:

- the Committee will continue work on revising the bylaws governing the operation of the Endowment Fund pending adoption of the amendment.
- will seek ways to raise awareness of the Endowment Fund, highlight the work the fund has done and can continue to do, and encourage giving to the fund.
- work toward developing a memorandum of understanding for donors.
- work on developing an Investment Policy Statement in consultation with RBC.

CREATION CARE TEAM REPORT FOR 2024

The Creation Care Team was formally established in October 2014. Its goal is to empower our congregation to be of part *Lutherans Restoring Creation*, an ELCA program that recognizes creation as a gift of God entrusted to our care. Lutherans Restoring Creation action plan has six areas of focus:

- 1) Worship
- 2) Education
- 3) Building and grounds as model
- 4) Discipleship at home and work
- 5) Public witness and policy
- 6) Promoting our care for creation identity in the congregation.

Creation Care Mission Statement

We recognize creation as a gift from God entrusted to our care. As a congregation, we will incorporate creation care into our worship life, educational program, the maintenance of building and grounds, our personal discipleship at home and work, and in our public witness. We seek to make caring for God's creation an integral part of the identity and mission of our life together.

Activities

1) Worship expressions of Creation Care:

We worshipped in our Memorial Garden all summer long with our songs and prayers. A Blessing of the Animals was held following worship on September 8, 2024

- 2) Single pain glass windows in furnace and quilt storage rooms have been covered with Styrofoam, reducing heat loss.
- 3) Lower door on the front of the church was replaced to reduce air infiltration into the church.
- 4) Lawrence Burkhard, LeAllan Estrem, and Randi Alreck attended the NE MN Synod/ELCA EcoFaith Network Summit "Cross & Currents in the Flood. Building Arcs Together for a Livable Planet." held at Glory Dei Lutheran Church, Duluth, MN on April 6, 2024. Keynote speaker was Larry Rasmussen, Christian environmental ethicist, awarding winning author of *The Planet You Inherit: Letters to my Grandchildren When Uncertainty's a Sure Thing*, and Reinhold Niebuhr Professor Emeritus of Social Ethics at Union Theological Seminary in New York City. His presentation:

We face uncharted territory, Larry Rasmussen warns in his recent book, *The Planet You Inherit: Letters to my Grandchildren When Uncertainty 's a Sure Thing.* We -- homo sapiens, that is -- stand at the edge of the abyss called the Age of the Anthropocene, the age of human domination of the entirety of nature. Addressed to his two grandchildren, Eduardo and Martin, the letters in this incredibly engaging book were written with deep regret to have been part of the crowd which has unfairly placed them before such immense difficulty. As their grandfather, Larry hopes to provide the boys (and us, with our progeny, of course), a map of "the world for a different way of life" in "a new age of discovery and a dangerous pilgrimage." The phrase captures both the sense of adventure and an awareness of peril which pervade the book.

CHRISTIAN EDUCATION REPORT FOR 2024

Youth program:

The Sunday School program continued using the Children's Church/Kid's Connect format. With the Children's Church/Kid's Connect format, the children attend the first part of the church service with the adults (parents/grandparents), and then, after opening prayers, they depart to their classes. The children return in time for Communion. Because of the limited attendance (often, 3 or 4 children), only one class is taught, and we are blessed to have 6 adults and 6 recently confirmed students in the teaching roles.

For Children's Church, the *Living The Word* curriculum by Spirit and Truth Publishing was used from January through May. This curriculum follows the Narrative Lectionary used by Pastor Susan in Church services. For September through December, the Holy Moly curriculum by Spark House/Augsburg Fortress was used.

Over the summer months, Dani Mattson led the children in crafts, coloring and playground exercises.

Vacation Bible School

VBS was led by Jillian McCorison and occurred on June 10-12, from 4:30-7 PM. The theme for VBS was *Set Sail*. The Bible stories were Jesus Fishes for Men, Jesus Calms the Storm and Jesus Walks on the Water. Patti Stoddard led the music, Vicky Gorman and Randi Alreck served the children dinners, and Olivia Smith and Sadie Pollard were teaching assistants.

Confirmation

Confirmation classes were held January through May and resumed in September. We are using "Here We Stand" lesson materials from SparkHouse.org purchased from Augsburg Fortress Publishing, and each child has a copy of "Here We Stand Lutheran Study Bible" for the class. There were five students the first half of the year, and three were confirmed last summer. Three students were enrolled as of the fall.

Children Church's Mission Project

The ELCA's Global Barnyard is the mission project for the children attending Children's Church/Kid's Connect, and the children take offering in class. The children thank the congregational members for their support of the mission project via coin boxes, offering envelopes, and VBS support.

Adult programs:

- The WELCA met monthly in the Fall, Winter and Spring for a Bible study.
- On Wednesday evenings during Lent, Randi Alreck led a group studying spiritual devotions with a book by Diana Butler Bass titled: *Grounded. Finding God in the World. A Spiritual Revolution.* The study met in-person.
- Over the year on Tuesday mornings, a group led by Randi Alreck and Pastor Susan met for *Lectio Divina/*Dig Deeper: readings and mediation on scripture. Meetings were done in-person and when weather permitted, meetings were done in the Memorial Garden.

WEBSITE AND YOUTUBE REPORT FOR 2024

Our website got a facelift in early September, and we have a new address (krlc.org). Much thanks to Jim Allert who put in countless hours on the new design. In the process we also changed providers from WIX to GoDaddy, making the updates and website administration significantly easier. However, it also means that the data we have is slightly different for the first 9 months than after the move, so you may notice and rejoice that there is less data in this report.

We continue to have a very strong viewing of our live-streamed worship services! Total YouTube views were down 15% from 2023 views, but still very healthy at 1,511. We continue to reach many who can't make it to services in person for various reasons and are very thankful to our dedicated technical team (Phil Berge, Jim Allert and Scott Shelerud) who faithfully record the services and keep the video system operational (quite an ongoing challenge)!

There was an average of over 27 computers logged into YouTube viewing 2024 Sunday worship services, down ~15% from 2023. It ranged from a low of 10 in February to a high of 69 in September. Similar to past years, we expect these counts are low as they don't reflect multiple people watching from one household and we rejoice at how much our live-streaming extends the ministry of our community church (particularly to those who can't make it in person temporarily or permanently, as this allows them to continue to participate)!

The website data for the first 9 months of 2024 also reflects a slight reduction from prior years. Similar patterns were observed with nearly as many visits on mobile phones as from computers. Approximately one-third of the website visits occur on Sundays and two-thirds are spread throughout the week. We also continue to see visitors from multiple countries.

TECHNICAL TEAM REPORT FOR 2024

In 2024, I made the following upgrades to our tech infrastructure:

The Internet service from Zito was increased from 100 MB/second to 1 GB per second - i.e. 10 times faster.

The Network modem was replaced as part of the Zito upgrade.

A new 'Power over Ethernet - POE' switch was installed, allowing the network cables to provide power to remote peripherals - cameras, antennas, etc. - and accommodating the higher bandwidth from the enhanced Zito service.

An Uninterruptible Power Supply was purchased to provide battery back-up power to the Zito Modem. This ensures that our emergency phone in the elevator will work in the event of a power outage.

I installed a new WiFi antenna for our outdoor service live-streams. This system will match up with the higher speed capability of the new modem and provides better signal strength and allows for more users.

Emergency repairs were made to our existing PA system. The repairs highlighted the need for a new mixing board which was purchased. Phil and I consulted with an audio engineer to properly match the new mixer with our existing system.

For 2025:

The Speakers in the basement will be replaced as part of the PA system upgrade.

The PA system and a new amplifier will be installed. I will work hard to get this done in time for PS's farewell ceremony.

Additional wireless microphones will be purchased to better accommodate live-streaming our various musical groups.

We still have some issues with our existing primary live-stream camera. I will continue to seek a resolution to this situation.

Pete Stoddard has stepped up to help out with the live-streaming, but we could still use additional help. Anyone else interested please let me know.

2024 Treasurer's report

There are just a few things that I want to communicate to you today.

- 1. A BIG "Thank You" to all of you!
 - Many churches are in financial trouble, but we are not! It's because of your dedication, commitment and generosity that makes this possible. THANK YOU!
- 2. KRLC finances are in excellent condition, and we are financially stronger today than at any other time. Here are just a few examples:
 - In 2024 our bank account values continue to grow in value, increasing by \$19,622.
 - Our main operating account and money market fund grew by \$9,193.
 - We have no debt!!!!
 - Our 2024 donations were right on the targeted budget (only \$103 short)
 - We had a small operating loss of \$984 on a budget of \$146,235.
 - We established a Money Market account with a current value of \$86,336 and earned interest for the first time in the amount of \$1,154 net after expenses. This money is in the designated account rather than the operating account.
 - We have money set aside in this account to pay for both a roof and a new furnace.
 - KRLC has an excellent financial system with many checks and balances built in.
- 3. I would like us all to think about the great impact this small group of people has. KRLC believes in community and world outreach by generously giving to worthy causes.
 - In 2024, \$12,272 was donated to local charities.
 - During this same time, \$12,619 was donated to world outreach.
 - Think about what these dollars mean to those who are less fortunate. How much has our small church affected them by giving \$24,892. I believe this is similar to what Jesus did when he multiplied the fish to feed the multitudes.
 - In addition, \$12,846 was paid to the NE MN Synod to support their activities.
- Budgeting for 2025 is not an exact science with our beloved Pastor retiring June 1st.
 - 1. The projected 2025 operating budget is \$164,263 which is a 12.5% increase from 2024 but this assumes that Pastor Susan was here the entire year.
 - 2. We know it's pretty accurate for the first 6 months and wrong for the 2nd six months.
 - 3. The Synod recommends that we pass a budget, as if Pastor Susan were here the full year, and know that our expenses will be <u>lower</u> in the second six months. I wish I could redo the budget with accurate number, but we just don't know what they are until later this year.
 - 4. This all comes down to faith! Faith that God will provide us a path through this valley, that our Call Committee and Church Council will make good decisions and faith in each other because we are the Church, and we are a strong congregation who pulls together when things need to get done or get tough. We have a long history to prove those facts.
- A big thank you to Michael Dent and Melanie McMillion for all their work in making the weekly financial details work for KRLC.
