Treasurers Report: The Treasurer gave a monthly Report: Donations are up but KRLC is running a bit below budget, however, there is great hope to be in balance with funds by the end of the year.

The Copy machine will need to be replaced soon, Ed Lee is doing research on the most cost effective way to replace the copier. At present KRLC runs about 30,000 copies a year. A Black and White Copier may cost about \$1,500 and a Color Copier may run around \$2,200.
