 - Karley:
 - CTHF will has an upcoming meeting of all provincial presidents to approve an amendment to a bylaw to better align with the IHF
 - New CEO confirmed receipt of member dues but wants to see the breakdown of member registration – Karley and Danielle to review who has it
 - Karley to meet with Tourism Winnipeg tomorrow (March 6th) to discuss ways they can support us
 - Cadie:
 - Karley and Cadie met with a contact from Brandon University with the aim of introducing handball in Brandon. Looking to start with a camp. Funding will be provided; Handball MB will need to provide “coaches” and equipment. Looking to get started with school-aged children (could be anywhere from elementary to high school)
 - Danielle was approached by Sask Jr. Women coach and discussed scrimmage or tournament between MB Sr. Women and Sask Jr. Women in Brandon. Suggestion from Karley to also include referees, run a clinic in Brandon

- However funding will be from City of Brandon, so we need to focus on doing things that benefit handball in Brandon. Karley advises not trying to make it a combination event in the first year
 - Could separate event from the camp, run a showcase to demonstrate handball, costs would then be between Sask and us
- o Alex:
 - With Alex departing, we will need to appoint an interested person into his role
 - Steph from Deep Blue expressed interest in the role, will require a formal vote in April
 - Danielle would appreciate board support with any scorekeeping gaps and volunteering at the windup
- o Spencer:
 - Interested in moving into the treasurer role, so Caitlin to modify the social media post to advertise Director of Operations instead of Treasurer
- Other Business
 - o Question about ref's representative going unelected. At what point do we prompt?
 - No intervention necessary from the board, it is purely a role that exists to provide the point of view of refs. It is up to them to elect someone.
