_____ I acknowledge that if I lose or damage lifejackets, paddles, kayak or paddleboard, the following expenses stated below may be charged to my credit card provided, as an additional charge to the rental fee.

KAYAK AND PADDLE BOARD RULES

- _____ Lifejackets must be worn at all times paddleboarding or kayaking.
- _____ Do not use paddles to push off the bottom, as it breaks the ends of paddles.
- _____ I will return the kayak/paddleboard empty of any trash or be subject to a \$10.00 cleaning fee.
- _____ No dragging kayaks/paddleboards across gravel, pavement, or concrete, as it causes holes.

RENTER'S DUTIES AND OBLIGATIONS

Renter hereby rents from **Paddles and Pedals** the foregoing watercraft equipment (the "equipment") for the period(s) and charges specified. Renter agrees, as further consideration for such, that Renter and all members of Renter's party will comply with the following Duties and Obligations.

_____ All rented equipment must be operated in strict compliance with Province of British Columbia and federal laws and in compliance with all safety and operating procedures provided under Rules paragraph. Failure to follow the law, procedures, rules, or verbal instructions authorizes **Paddles and Pedals** to immediately terminate this agreement. **Paddles and Pedals** reserves the right to refuse use of the equipment by anyone.

_____ Renter understands the Renter is hereby assuming responsibility for all persons in Renter's party, whether adults or minors, utilizing any of the equipment, and for their acts which may cause damage or injury to property or persons. Renter is in good health, not under the influence of alcohol or drugs and is otherwise capable of safely operating the equipment provided.

_____ Renter agrees to promptly return all equipment rented to the area rented from at the end of the rental period ("Return Time") in good condition. Renter agrees that Renter is liable for all "Additional Charges" as may be determined by **Paddles and Pedals** upon return of the equipment. Renter shall immediately notify **Paddles and Pedals** if equipment is damaged or stolen.

_____ Renter understands and agrees that **Paddles and Pedals** reserves the right to require Renter to relinquish the use of the equipment at an time due to unsafe or improper use. If, in the opinion of any **Paddles and Pedals** employee, Renter becomes incapacitated, violates any terms of this agreement, or allows unauthorized or unfit person(s) to operate equipment, Renter agrees and understands no portion of the rental fee will be refunded.

RENTER RESPONSIBLE FOR LASS OR DAMAGE AND COST OF REPAIR OF EQUIPMENT

_____ Renter agrees to pay the full cost of repairing any damage occurring to the equipment during the period rented under this agreement and/or while it is in the Renter's possession and control. Such cost of repairing will include not only all parts and labor, but also loss of revenue due to the "down time" as determined by **Paddles and Pedals**. Renter hereby authorizes **Paddles and Pedals** to charge the credit card provided on contract for the amount of damages/replacement costs incurred, immediately.
