AS WE SHOUT FOR GAZA, WE MAY SHOUT FOR LIBERTY AND DEMOCRACY FOR ALL PEOPLE. THE UNITED STATES OF AMERICA WILL HELP YOU. WE ARE THE WORLD NATION AND WE WILL FORCE OUT BIGOTRY, WE WILL NOT DISPLACE AMERICAN SOULS: CITIZENS, LONG TERM RESIDENTS, AND VISITORS.

WE ARE A FIRST WORLD NATION AND WE WILL HAVE FIRST WORLD ISSUES. WE DECIDED TO LEVEL UP AS HUMAN CRITICAL THINKERS WHEN WE REMOVED THE SUBSET OF AN IDENTITY TO MAKE ROOM FOR MORE DISCOURSE. REMOVE MY IDENTITY AS A WOMAN, REMOVE MY IDENTITY AS A PERSON OF COLOR, REMOVE MY IDENTITY ON SEX, REMOVE MY IDENTITY ON ORIENTATION, AND TREAT ME AS A HUMAN BEING FIRST IN A FIRST WORLD COUNTRY.

WE HAVE TO CHECK AND BALANCE OUR GOVERNMENT, JUST LIKE OUR CHECKBOOKS. BIGOTRY IN THE LAST THREE YEARS HAS ALLOWED THE FIRST WORLD NATION TO REMOVE MY IDENTITY IN HIGHER EDUCATION, REMOVE MY IDENTITY AS A WOMAN, AS A TAXPAYER, AND WILL CREATE PRECEDENT UNDER PEOPLE'S EYES THROUGH THE UNCHECKED JUDICIAL BRANCH. YOU MUST MAKE THE AUTONOMOUS CHOICE TO FOLLOW DEMOCRACY BUT DO NOT BECOME A MINDLESS FOLLOWER BECAUSE WHEN WILL YOU LOSE YOUR AUTONOMY?

I WAS RAISED IN THE MODERN AGE, POST-GOOGLE, AND I HAD TO CREATE SAFETY PARAMETERS BASED ON THE EXPERTS OF THAT TIME WHO WERE WARY OF A NEW AGE. NOW, WE MUST BECOME THOSE EXPERTS WHO HAVE DEVELOPED THEIR PREFRONTAL CORTEX DURING AN ERA WHEN WE WERE THE MOST MALLEABLE AND WERE ENGAGED WITH THE MOST AMOUNT OF INFORMATION IN HUMAN HISTORY.

MCCLESKEY V. KEMP, 481 U.S. 279 (1987)

U.S. SENATOR SCHUMER SAID THAT "OVER 300 OPINIONS OVER 13
YEARS AS A FEDERAL JUDGE" ALLOWED GINSBURG TO SHARE HER
OPINIONS THROUGH HER BODY OF WORK. THE FEDERALIST SOCIETY
ISSUED A PAPER ON THE GINSBURG CONFIRMATIONS SAYING THAT
THE JUSTICE'S GENERAL ANSWERS AND AVOIDANCE OF OTHER
QUESTIONS WERE BASED ON VALID REASONING, AND HER 96-3
CONFIRMATION VOTE SUPPORTED THAT THE U.S. SENATE
UNDERSTOOD THESE REASONS.

"NO HINTS, NO FORECASTS, NO PREVIEWS."

THIS CONTRASTS WITH WHAT HAS OCCURRED IN THE LAST EIGHT
YEARS WHERE WE HAVE DIVIDED THE JUDICIAL BRANCH JUST AS WE
DIVIDED THE LEGISLATIVE BRANCH AND I STRONGLY BELIEVE THE
EXECUTIVE BRANCH MAY, UNKNOWINGLY, BE DIVIDED.

THE MOST CONSERVATIVE SUPREME COURT CAME FROM OUR DEMOCRACY FALLING APART
STARTING JANUARY 20, 2017.

SUPREME COURT JUSTICE NEIL GORSUCH WAS NOMINATED JANUARY 31, 2017 EVEN THOUGH SCALIA
HAD PASSED FEBRUARY 2016. WE DID NOT HAVE PRECEDENT FOR THIS MOMENT IN U.S. HISTORY
WHERE A CIVILIAN WHO WANTED POWER OF THE STATE WOULD ABUSE THE STATE'S BRANCHES OF
GOVERNMENT FOR HIS OWN SELF-INTEREST. THIS INDIVIDUAL NOMINATED THREE CONSERVATIVE
JUDGES WHO HAVE NOW REMOVED PRECEDENT THAT EFFECTED THE FUTURE OF THE PEOPLE MLK
REFERRED TO IN HIS SPEECHES.

THIS ALSO OCCURRED WHEN AMY CONEY BARRETT WAS NOMINATED IN OCTOBER 2020 TO REPLACE
THE HONORABLE RUTH BADER GINSBURG, EVEN THOUGH AMY CONEY BARRETT ONLY HAD THREE
YEARS OF EXPERIENCE AS A JUDGE.

THE SENATE JUDICIARY COMMITTEE HELD HEARINGS ON BARRETT'S NOMINATION TO THE U.S.
SUPREME COURT FROM OCTOBER 12 TO OCTOBER 15, 2020. THE COMMITTEE VOTED 12-0 ON
OCTOBER 22, 2020 TO ADVANCE HER NOMINATION TO THE FULL U.S. SENATE. NO DEMOCRATIC
COMMITTEE MEMBERS ATTENDED THE MEETING TO VOTE ON ADVANCING HER NOMINATION.

WE WERE GETTING CLOSER TO THE PROMISE LAND WHERE OUR INTERSECTIONAL IDENTITIES
WOULD BE UNSEEN BECAUSE WE WERE ALREADY HIGHER CRITICAL THINKING AMERICAN SOULS.
HIGHER LEVEL OF CIVIL CONSCIOUSNESS FOR CIVIL DISCOURSE. THEREFORE, IF WE COULD DE-
SEXUAL WOMEN SO THEY ARE ALLOWED TO FEEL COMFORTABLE AT THE TABLE, WE CAN DISCUSS
OTHER PREVENTATIVE CONSEQUENCES OF THE POLARIZATION OF THE SUPREME COURT OF THE
LAND THAT ATTACKS IDENTITY MARKERS, WE, THE PEOPLE OF THE UNITED STATES, DO NOT WANT
REMOVED.

- THERE WAS A NIGHT CLUB SHOOTING JUNE 12, 2016 DUE TO THE REACTION OF INTERNATIONAL AFFAIRS INTO DOMESTIC SETTINGS.
- THERE ARE NOTABLE FIGURES WHO WALKED ALONGSIDE MLK BUT WERE SEEN AS RADICALS AT THE TIME, SUCH AS THE HONORABLE JOHN LEWIS, WHO WAS AN ADVOCATE FOR CIVIL RIGHTS AND STAGED THE SIT-IN ON JUNE 22, 2017 UNTIL JUNE 23, 2017 TO ATTEMPT, UNSUCCESSFULLY, TO DISCUSS GUN CONTROL REGULATION. HE ALSO SUPPORTED THE EVERY CHILD DESERVES A FAMILY ACT, WHICH ALLOWED ORGANIZATIONS SUCH AS FAMILY EQUALITY TO SEE LEGISLATIVE ACTORS INVOLVED IN PASSING BILLS FOR LEGISLATION FOR CHILDREN. I DO BELIEVE IN KEEPING THE HOUSE FLOOR ORDERLY BUT I ALSO APPRECIATE THE PEACEFUL PROTEST FOR THE PEOPLE.

JANUARY 20, 2017 DEMOCRACY WAS TESTED.

"DEMOCRACY DIES IN DARKNESS" FEBRUARY 22, 2017

THE WORD DEMOCRACY COMES FROM THE GREEK WORDS "DEMOS", MEANING PEOPLE, AND "KRATOS" MEANING POWER; SO DEMOCRACY CAN BE THOUGHT OF AS "POWER OF THE PEOPLE": A WAY OF GOVERNING WHICH DEPENDS ON THE WILL OF THE PEOPLE

- FROM THE START ROE V. WADE WAS FLAWED. IT DID SAY PEOPLE HAD THE RIGHT TO ABORTION, BUT IT NEVER PROTECTED PEOPLE'S ACCESS TO ABORTION.
- SINCE 2016 WE HAVE HAD FOUR NEW SUPREME COURT JUSTICES THAT HAVE BEEN CHOSEN BUT HAVE NOT HAD BIPARTISAN SUPPORT SUCH AS RUTH BADER GINSBURG: "NO HINTS, NO FORECASTS, NO PREVIEWS."
- IN 2016, JUSTICE SCALIA PASSED AND THE PRESIDENTIAL ELECTIONS WITH A HISTORICAL FEMALE INVOLVED WAS UNDERWAY. WE WERE JUDICIALLY GETTING REVAMPED AND EXECUTIVELY, SO THE LEGISLATIVE BRANCH WAS THE CHECK AND BALANCE REGULATOR.
 - THE 2014 ELECTIONS GAVE THE REPUBLICANS CONTROL OF THE SENATE AND THE HOUSE FOR THE FIRST TIME SINCE THE 109TH CONGRESS. WITH 248 SEATS IN THE HOUSE OF REPRESENTATIVES AND 54 SEATS IN THE SENATE, THIS CONGRESS BEGAN WITH THE LARGEST REPUBLICAN MAJORITY SINCE THE 71ST CONGRESS OF 1929-1931.
 - THE MOST CONSERVATIVE COURT STARTED IN 2020.
 - THE FIRST FEMALE HISPANIC SUPREME COURT JUSTICE SONIA SOTOMAYOR RECEIVED 2/3 APPROVAL. WE HAVE COMPLETELY DIVIDED VOTES FOR THE LAST FOUR JUSTICES: NEIL GORSUCH(2017), BRETT KAVANAUGH (2018), AMY CONEY BARRETT(2020), FIRST BLACK FEMALE SUPREME COURT JUSTICE KENTANJI BROWN JACKSON (2022).
 - AMY CONEY BARRETT HEARS HER FIRST CASE NOVEMBER 3, 2020 BECAUSE SHE WAS CONFIRMED OCTOBER 27, 2020 EVEN THOUGH SHE HAD THREE YEARS OF EXPERIENCE AS A JUDGE.
 - WE HAVE HAD NOTABLE DECISIONS EFFECT OUR LIVELIHOODS. STARTING WITH SUPREME COURT TERM 2020, CONSEQUENTLY, WE HAVE BEEN ON A DOWNWARD SPIRAL OF SELF-REGULATION WITH PARTISAN IDEALS.

**CURRENT UPPER MANAGEMENT OF ALL BRANCHES OF THE UNITED STATES NEED PROPER VETTING BY THE
PEOPLE OF THE UNITED STATES**

THE LIST OF ACCOMPLISHMENTS FOR THREE OF THE FOUR WOMEN ARE STAGGERINGLY HIGH AND A PERSON WHO WAS THE RESULT OF THE UNDEMOCRATIC BEHAVIOR OF THE 2020 ELECTIONS IS SEEN WITH HER BOYCOTTED NOMINATION AND VOTE BY A WHOLE POLITICAL PARTY. SHE IS ON THE HIGHEST COURT WITHOUT THE PROPER QUALIFICATIONS AND THAT IS AN EXAMPLE OF HOW THE REST OF THE UNITED STATES IS CURRENTLY EXPERIENCING LEADERSHIP.

- POLITICAL ANALYSTS AND MEDIA OUTLETS IDENTIFIED SEN. SUSAN COLLINS (R) AS ONE OF THE MOST IMPORTANT REPUBLICAN VOTES NEEDED FOR KAVANAUGH'S CONFIRMATION. COLLINS SUPPORTED LEGALIZED ABORTION AND SAID SHE WOULD NOT VOTE FOR A NOMINEE TO THE U.S. SUPREME COURT WHO WOULD OVERTURN ROE V. WADE.
- MCCLESKEY V. KEMP, 481 U.S. 279 (1987), IS A UNITED STATES SUPREME COURT CASE, IN WHICH THE DEATH SENTENCE OF WARREN MCCLESKEY FOR ARMED ROBBERY AND MURDER WAS UPHELD. THE COURT SAID THE "RACIALLY DISPROPORTIONATE IMPACT" IN THE GEORGIA DEATH PENALTY INDICATED BY A COMPREHENSIVE SCIENTIFIC STUDY WAS NOT ENOUGH TO MITIGATE A DEATH PENALTY DETERMINATION WITHOUT SHOWING A "RACIALLY DISCRIMINATORY PURPOSE."^[1] MCCLESKEY HAS BEEN DESCRIBED AS THE "MOST FAR-REACHING POST-GREGG CHALLENGE TO CAPITAL SENTENCING."

WHO ARE THE WOMEN ON THE SUPREME COURT OF THE UNITED STATES OF AMERICA:

OUR DEMOCRACY HAD ALREADY FALLEN APART BY NOT REGULATING ERRORS IN THE SUPREME COURT WHEN RBG PASSED HAS ALTERED MORE LAWS

1) SONIA SOTOMAYOR (2009)

WAS CONFIRMED BY THE U.S. SENATE ON AUGUST 6, 2009, ON A VOTE OF 68-31. SONIA SOTOMAYOR – THE FEARLESS FEDERAL TRIAL COURT JUDGE WHO SAVED MAJOR LEAGUE BASEBALL FROM A RUINOUS 1995 STRIKE – ENTERED THE RECORD BOOK AS THE FIRST HISPANIC AND THE THIRD WOMAN TO SERVE ON THE HIGH COURT. THE LEGENDARY MANHATTAN DISTRICT ATTORNEY ROBERT MORGENTHAU HIRED 25-YEAR-OLD SOTOMAYOR TO WORK IN HIS OFFICE FOLLOWING HER GRADUATION IN 1979. AS AN ASSISTANT DISTRICT ATTORNEY, SOTOMAYOR BEGAN WORK IN A TRIAL UNIT THAT PROSECUTED EVERYTHING FROM PETTY CRIMES TO HOMICIDES. SHE ESTABLISHED HERSELF EARLY AS AN IMPOSING PROSECUTOR WHO, DESPITE HER YOUNG AGE, WOULD NOT GET PUSHED AROUND. SOTOMAYOR HELPED PUT SOME OF THE MOST HEINOUS CRIMINALS BEHIND BARS AND TRIUMPHED IN HIGH-PROFILE CASES, INCLUDING THE FAMOUS TARZAN MURDER CASE AND A MAJOR CHILD PORNOGRAPHY BUST. IN 1984, SOTOMAYOR MOVED INTO PRIVATE PRACTICE WITH THE NEW YORK CITY LAW FIRM OF PAVIA & HARCOURT, WHICH FOCUSED IN BUSINESS AND CORPORATE LAW. SHE EXCELLED IN HER WORK ON INTELLECTUAL PROPERTY RIGHTS AND COPYRIGHT LITIGATION AND MADE PARTNER IN 1988.

ON THE RECOMMENDATION OF SENATOR DANIEL PATRICK MOYNIHAN, THE GEORGE H. W. BUSH ADMINISTRATION NOMINATED SOTOMAYOR TO THE UNITED STATES DISTRICT COURT FOR THE SOUTHERN DISTRICT OF NEW YORK ON NOVEMBER 27, 1991. HER MAJORITY OPINION IN CASTLE ROCK ENTERTAINMENT, INC. V. CAROL PUBLISHING GROUP FINDING A COPYRIGHT INFRINGEMENT ON MATERIAL FROM THE TELEVISION SHOW SEINFELD BECAME A STANDARD FOR APPLYING THE FAIR USE DOCTRINE. ON ANOTHER RECOMMENDATION FROM MOYNIHAN, PRESIDENT BILL CLINTON NOMINATED SOTOMAYOR TO THE UNITED STATES COURT OF APPEALS FOR THE SECOND CIRCUIT ON JUNE 25, 1997. DURING HER NEXT DECADE ON THE SECOND CIRCUIT, SOTOMAYOR WOULD HEAR MORE THAN 3,000 CASES AND WRITE AROUND 380 MAJORITY OPINIONS. HER CAREFULLY-WORDED TECHNICAL WRITING DID NOT GRAB MEDIA ATTENTION AND HELPED HER KEEP A LOW PROFILE. HOWEVER, THE LAWYERS WHO ARGUED BEFORE HER KNEW HER WELL, REMEMBERING VIVIDLY HOW SHE OFTEN CONFRONTED THEM SHARPLY FROM THE BENCH.

2) ELENA KAGAN (2010)

SHE STARTED AS A VISITING PROFESSOR AT HARVARD LAW. IN 2001, SHE WAS GIVEN FULL PROFESSOR STATUS, BUT KAGAN CLIMBED SO FAR AND SO QUICKLY UP THE LADDER THAT SHE BECAME THE DEAN OF HARVARD LAW SCHOOL IN 2003, A MERE TWO YEARS LATER. SHE SERVED AS THE DEAN FOR FIVE YEARS BEFORE A SECOND PRESIDENT CALLED UPON HER LEGAL MIND. AFTER BARACK OBAMA WON THE PRESIDENCY IN 2008, HE APPOINTED KAGAN TO BE THE FIRST FEMALE SOLICITOR GENERAL, AND IN 2009, THE SENATE CONFIRMED HER NOMINATION. THE FOLLOWING YEAR PRESIDENT OBAMA NOMINATED HER AS SUPREME COURT JUSTICE JOHN PAUL STEVENS' REPLACEMENT.

3) AMY CONEY BARETT (2020)

AMY CONEY BARRETT WAS A LAW PROFESSOR AT NOTRE DAME WHEN PRESIDENT DONALD J. TRUMP NOMINATED HER TO THE U.S. COURT OF APPEALS FOR THE SEVENTH CIRCUIT IN 2017. SHE SERVED AS A FEDERAL APPEALS JUDGE FOR THREE YEARS BEFORE BEING CONFIRMED AS A U.S. SUPREME COURT JUSTICE IN OCTOBER 2020.

ON SEPTEMBER 26, 2020—ONE WEEK AFTER JUSTICE RUTH BADER GINSBURG DIED AND ON THE EVE OF THE 2020 PRESIDENTIAL ELECTION—PRESIDENT TRUMP NOMINATED BARRETT TO THE SUPREME COURT TO FILL JUSTICE GINSBURG'S SEAT. HER SELECTION WAS EXTREMELY CONTENTIOUS, DUE IN LARGE PART TO THE HYPOCRITICAL PUSH BY SENATE MAJORITY LEADER MITCH MCCONNELL TO CONFIRM HER JUST BEFORE THE ELECTION DESPITE REFUSING TO HOLD A HEARING FOUR YEARS EARLIER ON PRESIDENT OBAMA'S SUPREME COURT NOMINEE, MERRICK GARLAND.

ON OCTOBER 22, 2020, THE SENATE JUDICIARY COMMITTEE VOTED UNANIMOUSLY (WITH THE DEMOCRATS BOYCOTTING THE VOTE) TO ADVANCE BARRETT'S NOMINATION, AND ON OCTOBER 26, THE SENATE CONFIRMED HER BY A 52-48 VOTE. SHE WAS SWORN IN BY JUSTICE CLARENCE THOMAS.

4) KENTAJI BROWN JACKSON (2022)

AFTER THREE YEARS IN PRIVATE PRACTICE, SHE WORKED AS AN ATTORNEY AT THE U.S. SENTENCING COMMISSION FOR TWO YEARS, AS AN ASSISTANT FEDERAL PUBLIC DEFENDER IN WASHINGTON, D.C., FOR TWO YEARS, AND AGAIN IN PRIVATE PRACTICE FOR THREE YEARS. SHE THEN SERVED AS A VICE CHAIR AND COMMISSIONER ON THE U.S. SENTENCING COMMISSION FROM 2010 TO 2014.

IN 2012, PRESIDENT BARACK OBAMA NOMINATED HER TO THE U.S. DISTRICT COURT FOR THE DISTRICT OF COLUMBIA, WHERE SHE SERVED FROM 2013 TO 2021. PRESIDENT JOE BIDEN APPOINTED HER TO THE U.S. COURT OF APPEALS FOR THE D.C. CIRCUIT IN 2021 AND THEN NOMINATED HER AS AN ASSOCIATE JUSTICE OF THE U.S. SUPREME COURT IN 2022. SHE TOOK HER SEAT ON JUNE 30, 2022, BECOMING THE FIRST BLACK WOMAN TO SIT ON THE COURT.

HEART OF ATLANTA MOTEL, INC. V. IN 2023, THE US SPACE AGENCY NASA HAS NAMED THE FOUR ASTRONAUTS WHO WILL TAKE HUMANITY BACK TO THE MOON, AFTER A 50-YEAR GAP. CHRISTINA KOCH WILL BECOME THE FIRST WOMAN ASTRONAUT EVER ASSIGNED TO A LUNAR MISSION, WHILE VICTOR GLOVER WILL BE THE FIRST BLACK ASTRONAUT ON ONE.
- 3) THE LOUISVILLE, KENTUCKY METRO COUNCIL PASSED 'BREONNA'S LAW,' A LAW BANNING NO-KNOCK WARRANTS AFTER THE TRAGIC KILLING OF BREONNA TAYLOR.

AS PEOPLE OF COLOR WE SAY "HAPPY MLK DAY" AND THANK YOU TO THIS MAN AND THE CIVIL RIGHTS MOVEMENT FOR OUR CIVIL RIGHTS ON JULY 2, 1964 THIS YEAR WE WILL CELEBRATE 60 YEARS OF THIS RIGHT "THE CIVIL RIGHTS ACT OF 1964 PROHIBITS DISCRIMINATION ON THE BASIS OF RACE, COLOR, RELIGION, SEX OR NATIONAL ORIGIN. PROVISIONS OF THIS CIVIL RIGHTS ACT FORBADE DISCRIMINATION ON THE BASIS OF SEX, AS WELL AS, RACE IN HIRING, PROMOTING, AND FIRING."

WE REMINISCED ABOUT LIFE IN THE LAST TWENTY FIVE YEARS; WE ARE GOOGLE KIDS AND THERE ARE NOW A.I. KIDS. THEIR CHILDHOOD AND ADOLESCENCE WILL DETERMINE THE TYPE OF ADULTS THEY WILL BE BUT WE HAVE UNREGULATED THE DEVICES IN THE WORLD. I WAS TRYING TO ENGAGE WITH THE MASSES ABOUT THIS IDEA THAT I GREW UP WANTING TO HELP OTHERS BECAUSE IT FELT THAT AS AN AMERICAN WE WERE RAISED IN BY OUR TEACHERS TO SAY "HELLO, NEIGHBOR! HOW CAN I HELP?" THIS SENTIMENT CREATED PRIDE THAT WE WERE ACTIVE FOR DUTY. AS MY BODY DETERIORATED, I WAS ABLE TO PAUSE AND RETHINK ATTENTION, TIME, AND MATERIAL WEALTH. RETHINK ATM. AT THE MOMENT, ALL THAT MATTERS IS ATTENTION, TIME AND MATERIAL WEALTH.

WE STARTED OBSERVING THIS OVER TEA TIME. OUR VERY EXISTENCE TORTURED OUR BIG BROTHER GOVERNMENTS RESPECTIVELY. I WAS A CIVILIAN REPRESENTATIVE OF THREE NATIONS AND MY FRIEND AS WELL. WE ARE UNIQUE CONSULS BECAUSE WHEN OUR IDENTITIES ARE ACCEPTED, A LARGE GOVERNMENT BODY HAS TO KNEEL AND GIVE IN TO OUR DEMANDS. FOR EXAMPLE, MY HOUSEHOLD HELD THE AMERICAN, CHINESE, AND COLOMBIAN CULTURES EVEN THOUGH GENETICALLY BOTH MY PARENTS WERE COLOMBIAN BORN AND IMMIGRATED TO THE UNITED STATES IN THE 1970S AND 1980S. MY FRIEND WAS A MIX BREED FROM MAINLAND AND HONG KONG AS WELL AS AMERICAN BUT LOVED INCLUDING LATIN AMERICAN CULTURE.

ROMANS CONSIDERED THE CONSULSHIP THE SECOND-HIGHEST LEVEL OF THE CURSUS HONORUM—AN ASCENDING SEQUENCE OF PUBLIC OFFICES TO WHICH POLITICIANS ASPIRED—AFTER THAT OF THE CENSOR, WHICH WAS RESERVED FOR FORMER CONSULS. IN THE TIMES OF IMPERIAL CHINA, SCHOLARS AND ARTISANS AFFILIATED WITH THE COURT WERE OFTEN DETACHED FROM THEIR HOMETOWNS FOR EXTENDED PERIODS OF TIMES AS PART OF THEIR DUTIES AND LOYALTIES AS COURTIER OR WORTHY SUBJECTS TO THE EMPEROR OF CHINA.

WHILE IT WAS EXPECTED IN TRADITIONAL CONFUCIAN RITUAL TO REMAIN A LOYAL SUBJECT TO THE EMPEROR AND ABIDE BY THE EMPEROR'S WISHES, FILIAL PIETY ALSO FORMED ONE OF THE FOUNDATIONS OF CONFUCIAN THOUGHT, AND EMPHASIZED UPON THE IMPORTANCE OF EMBRACING AND HONORING ONE'S ANCESTRY AND ROOTS. THROUGH THE POEM, LI BAI FULFILLS RESPONSIBILITIES OF FILIAL PIETY TO BOTH EMPEROR AND HIS ASCENDANTS AS HE EXPRESSES HIS YEARNING FOR HIS HOMETOWN, IN ACCORDANCE WITH CONFUCIAN VALUES, AS WELL AS OBEDIENCE TOWARDS THE SAD OBLIGATION OF REMAINING LOYAL TO IMPERIAL EDICT, AGAIN IN ACCORDANCE TO CONFUCIAN VALUES OF FILIAL PIETY. INDEED, THE POEM ALLUDES TO THE AUGUST MOON AND THEREFORE THE MID-AUTUMN FESTIVAL. THE MID-AUTUMN FESTIVAL SERVES AS A HIGHLY IMPORTANT FESTIVAL IN CHINESE CULTURE FOR ITS ADHERENCE TO CHINESE FAMILY VALUES, AND IS TRADITIONALLY ASSOCIATED WITH FAMILY REUNION.

LI IS THEREFORE LAMENTING OVER THE IMPOSSIBILITY OF FAMILY REUNION DUE TO THE IMPORTANCE OF THE IMPERIAL EDICT, YET STRESSES THE IMPORTANCE OF VALUING ONE'S ORIGIN EVEN AMIDST THE IMPOSSIBILITY OF REUNION.

ECUADOR HAS LONG SEEMED A PEACEFUL COUNTRY IN SOUTH AMERICA, SAFE FROM DRUG CARTELS AND GANG VIOLENCE - UNTIL THIS WEEK. A GROUP OF GUNMEN TOOK OVER A TV STATION IN GUAYAQUIL ON TUESDAY AND HELD STAFF HOSTAGE DURING A LIVE BROADCAST. THE GUNMEN WERE EVENTUALLY DETAINED BY SECURITY FORCES. NOBODY WAS KILLED AT THE TV STATION, BUT IT WAS JUST ONE OF A SERIES OF ALLEGEDLY COORDINATED ATTACKS THAT ROCKED ECUADOR OVER 24 HOURS. MORE THAN 30 CAR BOMBS WENT OFF ACROSS THE COUNTRY. RIOTS BROKE OUT IN SEVERAL PRISONS. AT LEAST 11 PEOPLE HAVE BEEN KILLED THIS WEEK. ECUADOR'S PRESIDENT, DANIEL NOBOA, DECLARED A STATE OF EMERGENCY AND SAID, WE ARE IN A STATE OF WAR. SEBASTIAN HURTADO IS FOUNDER AND PRESIDENT OF THE POLITICAL RISK CONSULTANCY GROUP PROFITAS THAT'S BASED IN QUITO. HE JOINS US NOW. THANKS SO MUCH FOR BEING WITH US, SIR.

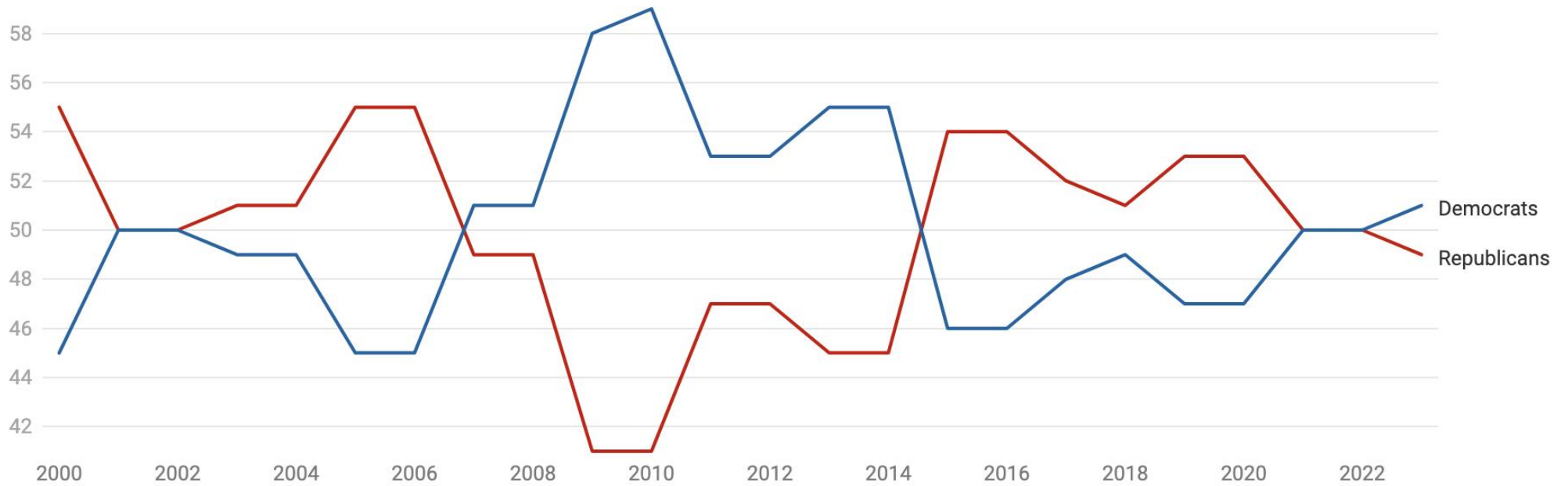

AROUND 2016, COLOMBIAN GUERRILLAS IN THE SOUTH OF COLOMBIA GOT DEMOBILIZED, AND THAT CREATED A VACUUM OF LEADERSHIP IN THE DRUG TRADE. AND NEW CRIMINAL ORGANIZATIONS TOOK OVER AND STARTED EXPLORING NEW WAYS OF MOVING DRUGS AROUND THE REGION. AND ECUADOR PROVIDED, LIKE, AN EXCELLENT BASE TO MOVE DRUGS AND EXPORT THEM FOR MANY REASONS - ONE BEING ECUADOR IS A FULLY DOLLARIZED ECONOMY. SO THAT MAKES USING THE U.S. DOLLAR EASIER AND LAUNDERING U.S. DOLLAR EASIER. AND THE SECOND THING IS, YOU KNOW, ECUADOR HAS VERY WEAK SECURITY AND STATE INSTITUTIONS.

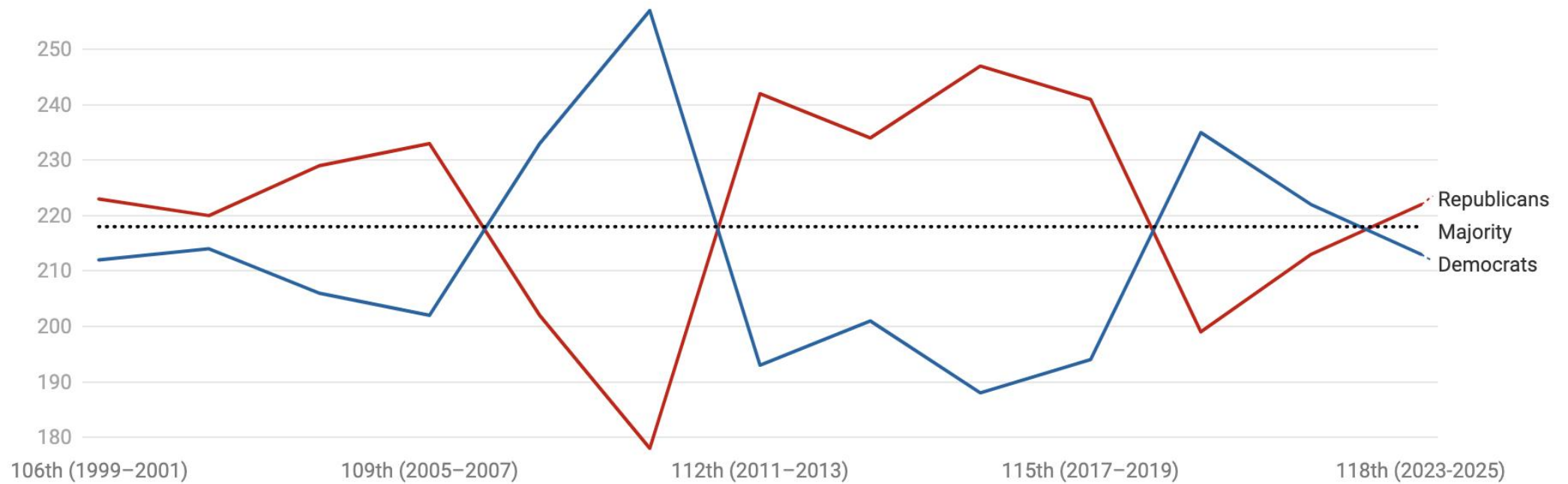

Partisan control of the United States House (1999-2023)



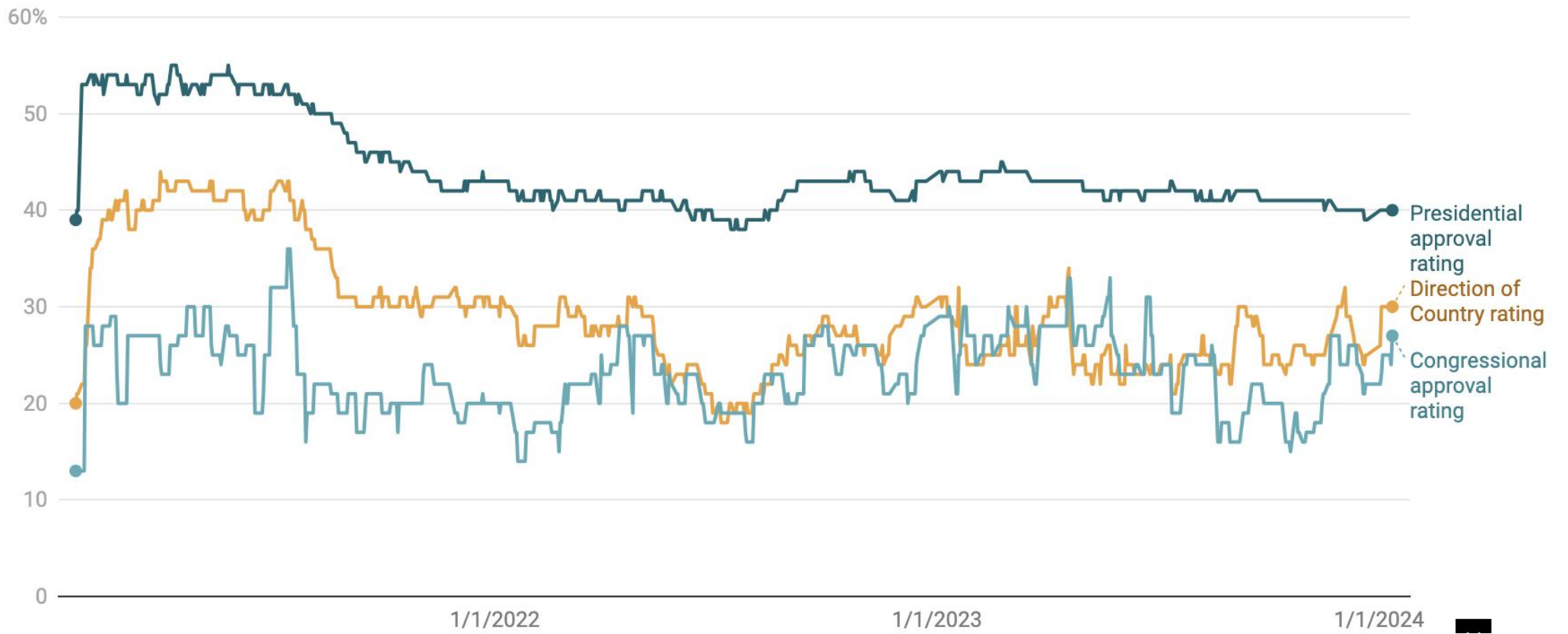

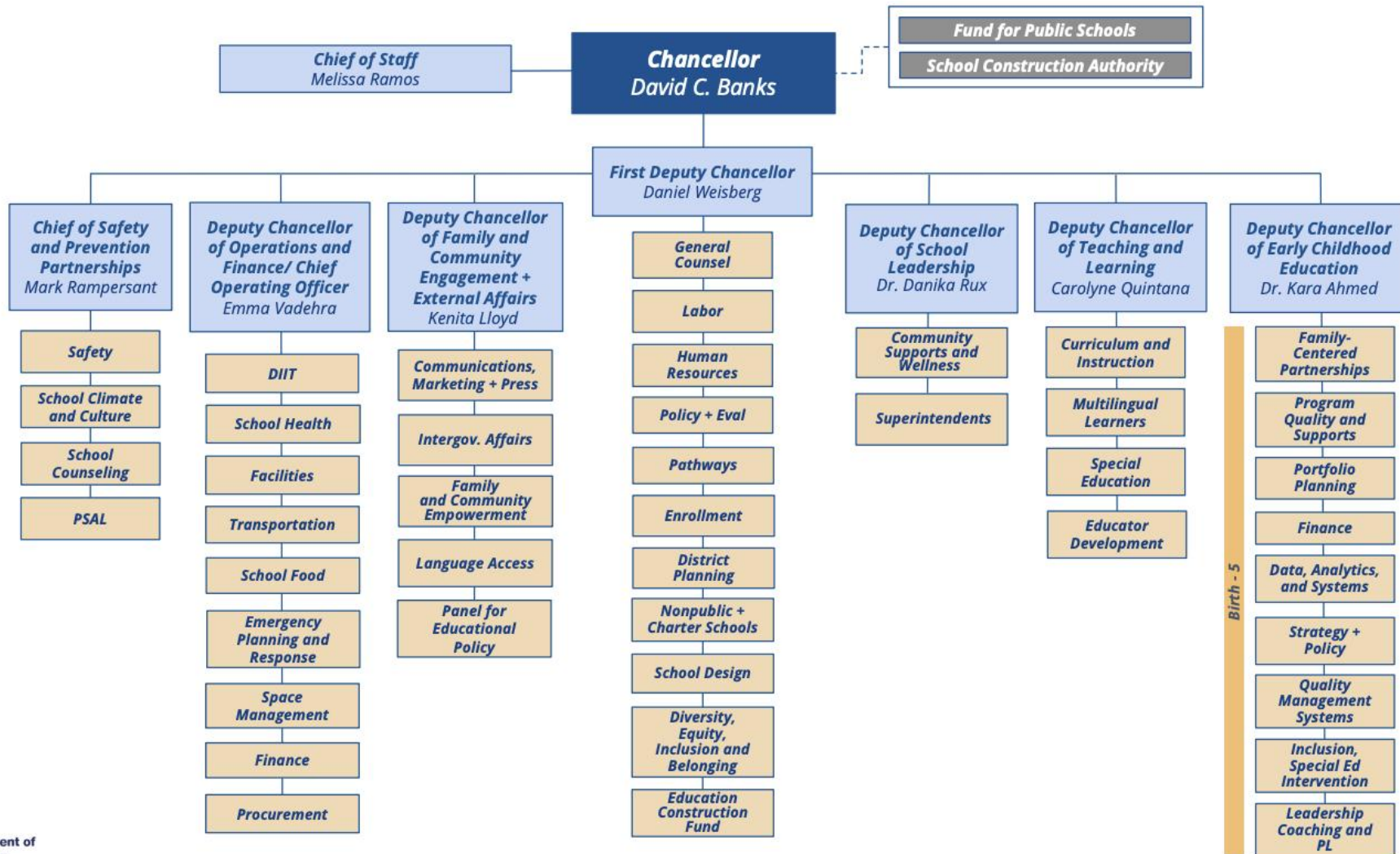

How do we ensure AI systems much smarter than humans follow human intent?

Currently, we don't have a solution for steering or controlling a potentially superintelligent AI, and preventing it from going rogue. Our current techniques for aligning AI, such as reinforcement learning from human feedback, rely on humans' ability to supervise AI. But humans won't be able to reliably supervise AI systems much smarter than us,^B and so our current alignment techniques will not scale to superintelligence. We need new scientific and technical breakthroughs.

[B] Other assumptions could also break down in the future, like favorable generalization properties during deployment or our models' inability to successfully detect and undermine supervision during training.

Our approach

Our goal is to build a roughly human-level automated alignment researcher. We can then use vast amounts of compute to scale our efforts, and iteratively align superintelligence.

To align the first automated alignment researcher, we will need to 1) develop a scalable training method, 2) validate the resulting model, and 3) stress test our entire alignment pipeline:

Our approach

Our goal is to build a roughly human-level automated alignment researcher. We can then use vast amounts of compute to scale our efforts, and iteratively align superintelligence.

To align the first automated alignment researcher, we will need to 1) develop a scalable training method, 2) validate the resulting model, and 3) stress test our entire alignment pipeline:

1. To provide a training signal on tasks that are difficult for humans to evaluate, we can leverage AI systems to assist evaluation of other AI systems (*scalable oversight*). In addition, we want to understand and control how our models generalize our oversight to tasks we can't supervise (*generalization*).
2. To validate the alignment of our systems, we automate search for problematic behavior (*robustness*) and problematic internals (*automated interpretability*).
3. Finally, we can test our entire pipeline by deliberately training misaligned models, and confirming that our techniques detect the worst kinds of misalignments (*adversarial testing*).

We expect our research priorities will evolve substantially as we learn more about the problem and we'll likely add entirely new research areas. We are planning to share more on our roadmap in the future.
