President Report – Scott Zimmermann

Vice President's Report - Deb Koltis

- Again, use the website calendar for your events.
- A membership program continues to be elusive there is a program, cost is ~\$600.00/yr but requires a dedicated network server; there are other programs which have much higher costs. Deb is looking into the feasibility of Google Workspace as another possibility which may fit the WTA needs: monthly costs range from ~\$5.00 to \$27.00 depending on the amount of data storage volume.
- The Trapper's Post has the most up to date mailing list of WTA members. The WTA now has a non-profit bulk rate mail number with an independent mail service.
- A meeting is being scheduled with Steve Van to develop solutions for the aging membership list, a suggestion is to request a mailing list rather than a membership list for their districts.

New Business: Insurance – Jody Zuelsdorff

- Extensive discussion of the WTA needs for insurance going forward.
- The current insurance is with West Bend Mutual @ a cost of \$12273.00 thru 11/21/2025
 - o Commercial General Liability Coverage: 1 million/2 million total aggregate limit
 - Commercial Inland Marine Coverage: \$2000/trailer, unscheduled misc. property
 >\$1000/item
 - Umbrella Liability Coverage: additional 5 million after exhausting liability limit with exclusions.
- Identified Coverage Gaps -
 - Liability coverage on WTA owned trailers, property damage or bodily injury caused by our trailers and no specific cargo/contents coverage.
 - Director and Officer Liability Coverage during performance of their duties.
 - o Cyber Liability Coverage, no coverage for attacks or leaking of personal data.
 - Bond coverage for misappropriated funds.
 - Employment Practices Liability Coverage
 - Worker Compensation Coverage.
- Complete trailer info needed by April 1 to Jody for purposes of scheduling items.
 - Value of trailer contents fur kits, traps, other supplies and equipment
 - Copies of titles, certificate of Ownership, purchase receipts, VIN #, storage locations, value of after-market shelving.
- Investigate must have coverages
 - Commercial General Liability Coverage
 - Commercial Inland Marine Coverage (individual trailer property value)
 - Liability coverage on WTA owned trailers
 - Director and Officer Liability Coverage
 - Cyber Liability Coverage
 - Bond coverage for misappropriated funds
 - Philadelphia Insurance Company a national ins. company: \$16334/yr (Est) w/o trailer info.
 - Secura Insurance Company specializes in not-for-profit organizations: \$6665/yr
 (Est) w/o trailer info.
 - President gave Jody permission to talk with our current insurance company,
 West Bend Mutual Insurance to obtain updated quotes for comparison.
