<u>CORRESPONDENCE</u>: The following correspondence was provided to the Board for informational purposes.

The District received a certification letter of the November 4, 2014 General Election pertaining to Fire Protection District 11 from Whatcom County Auditor's Office. Proposition 1 received 72.57% in favor of an increase of the previous real property tax and therefore, passed.

Lummi Island Heritage Trust (LIHT) reviewed the water tank maintenance agreement between LIHT and the District. The Committee agreed it is in order and that there were no issues that needed to be addressed.

The District received notice from DNR that our 2015 Volunteer Fire Assistance Phase II grant application was not selected for funding this year.

UNFINISHED BUSINESS:

At 7:33 p.m. the Board of Commissioners went into executive session Per RCW 42.30.110 to discuss Chief McLane's employee contract. It was announced to the public that the executive session would end at 7:48 p.m.

NEW BUSINESS:

Secretary Lish stated that she is waiting on information from our contact Melanie Piccin at Washington State Department of Retirement Systems (DRS) regarding enrollment in LEOFF Plan. The District will be required Per Chapter 41.26 RCW Law Enforcement Officers' and Firefighters' Retirement System and Chapter 415-104 WAC Law Enforcement Officers' and Firefighters' Retirement System to enroll once the District enters into employment contracts with the Fire Chief and the Assistant Fire Chief per RCW 41.26.030 (16) which defines the meaning of "firefighter" and their duties.

Chief McLane asked the Board to consider Position 1 title and duties to becoming the Assistant Chief. The newly hired full-time employee for 2014 has been beneficial to the Districts operations and the District as a whole.

<u>Motion</u>: Commissioner Bill Lee made motion, "To approve Position 1 duties and its title be assumed as the Assistant Chief." Motion seconded by Commissioner Ed Scott, AND PASSED 3-0.

Chief McLane provided the Board with the Battalion 38 job description and requirements for approval.

<u>Motion</u>: Commissioner Bill Lee made motion, "To approve the Battalion 38 job description and requirements as Chief McLane submitted them." Motion seconded by Commissioner Ed Scott, AND PASSED 3-0.
