#### **2012 ANNUAL REPORT**

At the end of 2011, the District was awarded a \$240,000 regional grant from FEMA to replace all the ambulance cots in Whatcom County. Every fire agency in Whatcom County helped out by participating in product research, demonstrations, and the bidding process. Everyone invested many hours to complete the project but the ergonomic design and greater weight capacity of the new cots alone made it worthwhile.

Tammi Lynch served as Financial Officer and Secretary to both the Chief and Commissioners for the past 5 years. In August, Tammi accepted a full time job and had to step down. It was a pleasure having Tammi as an employee, and we wish her well in the future. Lisa Lish, Island resident, volunteer EMT and Firefighter was hired part time to replace Tammi. The District received a good audit report for the 2008 and 2009 calendar years from the Washington State Auditor's Office. It included the comment: "It is clear the District has a firm hand on its operations and controls over district assets". As Financial Officer, Tammi played a large roll in the success of the Audit.

With a new County Executive and new City of Bellingham Mayor, the progress for a new EMS system paused. It took them a few months to become familiar with what had been accomplished before they resumed deliberation on the future system. Instead of one contract for both administration and service provider, one contract will be specific to administration, and a separate one for each service provider. Commissioner Busch has been involved with the issues of EMS since he was first elected Commissioner in 2001 and was one of the few that were asked to help the new Executive and Mayor get up to speed and help with the frame work of the contracts.

There are constant challenges to keep up with the ongoing changes and maintain compliance with all the federal guidelines and state statutes that regulate the District. Although overwhelming at times, 90% of them are designed for the safety of the firefighters and public they serve. With the increasing demands for administration duties and recognizing that future demand will consistently expand, the Board of Commissioners increased the Chief's time to 40 hours per week to help meet these needs. This year, the Board will be looking at different funding models for the ongoing and future needs of the department, including the impact on taxpayers.

The Federal Communication Commission set a mandate several years ago that all public service agencies shall be narrow band compliant by January 1, 2013. With a grant in 2009, our entire communication system was replaced to meet the mandate. Unfortunately, the system that activates the siren had been overlooked. While addressing this issue, we built a small radio room to house the station radio, MURS (Disaster Prep) system, and a little desk space for HAM Operators in the event we are completely cut off from the mainland. The biggest challenge to narrow banding was getting all county fire agencies on the same page so the switch over could occur in a matter of minutes. There was more agency coordination with frequencies and programing that I had ever seen before. I seriously doubted we could pull it off. Somehow we did and there were very few glitches considering the enormity of the project.

Using 2010 aerial photos of the island and mapping software, we created a new map of the District with every known address on it. In addition, we created map books for every vehicle. These allow responders to pin-point incident locations before heading out the door and to have more detailed information at their fingertips when they arrive.

After 15 years of service, the engine developed a pump leak, a job that could not be done here at the station. Fire District 21 was kind enough to loan us an engine for the duration of the repairs. Luckily we did not need it.

We continued bringing our newest folks up to speed with a fundamentals class in addition to the Thursday night trainings. Our EMS instructors continue to provide us with excellent training and skills practice. The American Heart Association published new CPR guidelines in 2012 focusing more on continuous compressions.

In 2012, the volunteers dedicated over 2,050 hours serving you; 378 hours on emergency responses, 1,324 hours on-going training, and 348 hours on weekly truck inspections. They spend many more undocumented hours writing reports and putting apparatus back in service after each call.

Listed below are the unpaid professionals who dedicated their time to your community in 2012. Please note the years of service for each and the group's wide range of professions. I appreciate and feel very lucky to have true community-based responders; many other departments in the county have members who serve only 3-5 years before moving on. Following the membership list, I am pleased to provide a snapshot of the 2012 financial activity, the 2013 budget, fund account balances at the end of 2012, and the emergency response data from 2012.
