CALL TO ORDER: Chairman Bill Lee at 3809 Legoe Bay Road, Lummi Island, WA 98262 called the Regular Meeting for March 8, 2016 to order, at 7:00 p.m.

CHIEF'S REPORT: Chief McLane reported that Engine 38 had a coolant leak while on a call in Scenic Estates. After further investigation of the engine it was found that the water pump pulley was cockeyed so the Engine was towed back to the Station and was repaired the following morning by Motor Trucks.

The electrical work has been completed to the Parish Nurses container. Chief McLane is still working on a draft facilities use agreement for the District to enter into with the Parish Nurses

Chief McLane gave an update on the computer and facilities technology upgrade project. At this time the Chief requested that the Board amend the 2016 budget for a new line item for capital for this project. \$7000.00

UNFINISHED BUSINESS: As reported in the Chief's Report, Chief McLane is still working on a draft facilities use agreement for the District to enter into with the Parish Nurses.

NEW BUSINESS: Chief McLane and Secretary Lish reported difficulties with obtaining and receiving information from KeyBank regarding our credit card with them, and unfortunately this is not new. Chief McLane did some research and US Bank offers credit card purchasing programs to government agencies under a State contract. They have programs that would fit our needs better, setting limits on cards and they have rebate programs. Chief McLane asked the Board to approve acquiring two new cards with US Bank; one would be for purchases and the second for travel. The US Bank cards would replace the KeyBank card and the KeyBank card account would be canceled.
