Secretary Lish will send an email out on Thursday to gather calendars to schedule a budget workshop in regards to the EMS levy replacement. Facilities tabled at this time.

**NEW BUSINESS:** The Board held a discussion on future meetings; in-person for Board members with public on zoom vs. all zoom. It was decided that at this time the Board would continue to meeting over zoom.

Chief McLane requested that the budget for Disaster Prep be increased to \$12,937.89. The division has two private donations in the amount of \$3,119.89 and the 2021 Fire Adaptive Communities Grant in the amount of \$10,318.00.

Commissioner Wendell Terry made motion, "To increasing the Disaster Prep budget to \$12,937.89" Motion seconded by Commissioner Steve Kopanos, AND PASSED 3-0.

Chief McLane requested that Nick Kluge be added to payroll as a backup maintenance person when Chris Immer is not available.

Commissioner Bill Lee made motion, "To add Nick Kluge to payroll" Motion seconded by Commissioner Wendell Terry, AND PASSED 3-0.

Chief McLane asked for clarification on motion 7 (For the remainder of 2021 the Board of Commissioners will approve or deny all promotions, and will approve hiring or dismissal of any member) voted on during the May 7th, 2021 meeting. Currently there is a "pre-accepted phase and an accepted phase. After discussion the Board agreed to be involved at both phases.
