The district also received a rate increase notice from the SOA. As of January 1, 2019 their hourly rate for local government audit work will be \$100, up from \$75. Their fraud investigation rate will be \$125 and their travel rate is 75% of the hourly rate.

<u>UNFINISHED BUSINESS</u>: Chief McLane provided a draft payroll policy for the board to review. Having a payroll policy in place was a verbal recommendation made by the SAO.

Commissioner Wendell Terry made motion, "To have Chief McLane start on the policy and procedures for the Fire Prevention/Disaster Preparedness Division of the District" Motion seconded by Commissioner Bill Lee AND PASSED 3-0.

NEW BUSINESS: The annual WFCA Conference is in Yakima from October 24th through the 27th. The Commissioners will confirm their availability and get back to Secretary Lish so rooms can be reserved.

The board and Chief McLane had discussion on the Tahoe needing the lifters repaired.

Chief McLane stated he would like us to start budget planning in September for upcoming needs. The board will get dates to Secretary Lish to set a date for a budget workshop.
