#### **PAYROLL**:

**<u>FINANCIAL/SECRETARY REPORTS</u>**: Secretary Lish gave the November Financial Report. The Board of Commissioners requested that Secretary Lish add the KeyBank monthly statements showing payroll to the financial report along with the County's monthly statements.

## **COMMUNICATIONS**:

Per Diem Rate change: Beginning on January 1, 2015 the standard mileage rates for the use of a car, van, pickup or panel truck will be 57.5 cents per mile for business miles driven, up from 56 cents in 2014.

Acceptance and thank you letters between PSE and LICA regarding the award of a grant for \$20,000.00 for an emergency generator for the Fire Station was provided.

Results of the Districts accountability audit from January 1, 2012 through December 31, 2013 from Washington State Auditor was provided for review. No findings were reported but two recommendations were made.

- Receipts are not regularly reconciled to deposits by persons with no cash or check handling responsibilities due to limited resources. The State Auditor recommended the District establish monitoring controls to review cash receipts reconciliations regularly. Chief McLane and Secretary Lish will both reconcile cash receipts monthly.
- During the review of the District's financial statements, the State Auditor noted there were variances in revenue and expenditures between what the District reported and what the County reported. The State Auditor recommend the District to reconcile the differences found between its Schedule 01 and the County's Schedule 11 revenues and expenses. Chief McLane has spoken to the County for some clarifications and is waiting to hear back from Neyda Flores, Assistant State Auditor, that the variances have been resolved to the Auditors satisfactory.

#### **UNFINISHED BUSINESS:** None.

#### **NEW BUSINESS:**

Credit and Fuel Card Policy updated 2-4-2015. The District has added a Whatcom Farmers Co-Op fuel card to this policy.

## <u>Motion</u>: Commissioner Ed Scott made motion, "to except the updated Credit and Fuel Card Policy." Seconded by Commissioner Bill Lee, AND PASSED 3-0.
