The Klamath County Fire Defense Board has divided Klamath County into four Fire Managements Zones: North County, Central County, Southwest County and Southeast County. Klamath County Structural Fire Service uses a four digit identification numbering system. This system is unique to the Structural Fire Service Agencies of Klamath County. Also included for interoperability purposes are others who may be called upon in the event of an incident. Those Agencies who assign personnel identification numbers, those numbers are agency specific and has no impact on this numbering system.
