Hello everyone!  
We hope you are enjoying this awesome weather this week!

Garrett and I talked to Heva this morning. He said to excavate current debris/materials, dispose of debris/materials and prepare the aggregate base for installation, it would be around \$33,000 for all (4) courts. If he is able to recycle any aggregate/stone under the oyster shell, it would further reduce the cost. This does not include drainage as the aggregate base is intended to do so under the Foreverlawn product. Once preparations are completed, our team would come in and install the Foreverlawn product.

We would coordinate with Heva and his team to install the first set of boards prior to installing the Bocce product. Then, we would install the plastic boards in your choice of color during our team's installation for the side walls (all included in our estimate). The color selection is great for these products and would give your courts a new, updated and unique look!

Please let us know which of the options below you would like to discuss and/or proceed with:

- Concrete (2) or (4) courts with the Foreverlawn Bocce product (Heva's first estimate combined with our estimate. Both would be approximately 1/2 of the current estimate(s) for (2) courts).
- Utilize the aggregate base for (4) courts with the Foreverlawn Bocce product (Heva's estimate above combined with our estimate)
- Schedule a time to talk with Dan, our financing partner with FINANSWR, to discuss financing options
