Trip Agreement and Release of Liability Form

Indemnification

As lawful consideration for being permitted by Tech Center Ski Club ("TCSC") to participate in activities sponsored, sanctioned, approved or organized by TCSC, I hereby agree that I, my heirs, distributees, guardians, legal representatives and assigns will not make claim against, sue, attach the property of, or prosecute TCSC for injury, death or damage resulting from the negligence or other acts, how so ever caused, by an officer, director, member or contractor of TCSC as a result of my participation in trips, races, or other activities. In addition, I hereby release and discharge TCSC from all actions, claims, or demand I, my heirs, distributees, guardians, legal representatives, or assigns now have or may hereafter have for injury, death or damage resulting from my participation in TCSC activities. TCSC reserves the right to withdraw the trip, or to refuse to accept or retain any person as a member of the trip at any time, or to make changes, in the transportation, lodging or published itinerary whenever, in their sole judgement, conditions warrant. The participant's ticket in use by the airlines, when issued, shall be the sole contract between the airlines and the participant. Airlines concerned are not responsible for any act, omission or event during the time participants are not onboard aircraft. The liability of the carriers for baggage is limited to the stated liability policy. Liability other than that stated by the carriers is at the owner's risk and TCSC is acting only in the capacity of agent providing means of transportation or other services. The price of this trip is based on quoted tariffs and if prior to departure time, the tariffs are higher or lower than those quoted the price of the trip may be adjusted accordingly. Neither the Trip Operator, its agents, nor the airline are to be responsible for lack of snow or non-operation of lifts at ski resorts, or for closure of access routes to and from resorts due to snow or weather conditions, nor are they to be held liable for any additional expenses or consequences arising there from. Similarly they are not to be responsible for the late arrival of participants at airports or at resorts due to inclement weather, or road conditions or any other reasons beyond their control; nor are they liable for payments of any refund for unused hotel accommodations, meals or other inclusions occasioned by such late arrivals at the lodge holding rooms as per confirmed itineraries. All baggage and personal belongings shall at all times remain in the sole custody and control of each trip participant. Such possessions shall be transported at the owner's sole risk of loss.

Cancellation/Substitution Policy

A refund will be made if for any reason TCSC cancels the trip. After full payment deadline, if trip participant makes cancellation and an eligible substitute is available, canceling participant will be refunded any recoverable payments less a \$200 TCSC cancellation/transfer fee. In the event of a cancellation, refunds will not be made until actual unrecoverable expenses incurred have been fully determined. No refunds will be made until completion of the trip. Trip interruption or cancellation insurance is available through independent sources and is highly recommended.

Participants have the right and responsibility to negotiate the sale/transfer of the trip package, subject to the Trip Leader's approval with first opportunity to those on the trip wait list. The replacement must meet the TCSC major trip criteria, sign all necessary waivers and with all transfer fees paid before the transfer is considered complete.

\$2700 and includes Group Air Travel, Ground transportation, Lodging and 5 days lift ticket
