Mr. Taylor,

Based upon 49CFR, Part 26.85, the Iowa Department of Transportation recognizes your DBE certification from the Pennsylvania Unified Certification Program.

Enclosed with this approval letter is your DBE Certification certificate. Your firm's name will be placed in the Iowa Department of Transportation's Directory of Certified DBEs for the same work types/North American Industry Classification System (NAICS codes) as listed by your home state.

Annually you will be required to submit an Affidavit of Continued DBE Certification Eligibility Form (provided by this office), a No Change Affidavit, and all supporting documentation.

IMPORTANT: Please note that under lowa Code section 91C.2, before an out-of-state contractor can do business in Iowa, s/he must be registered with the labor commissioner. In order to register, you will be required to post a surety bond in the amount of twenty-five thousand dollars **OR** provide a statement to the division of labor services that you are prequalified to bid on projects for the Iowa Department of Transportation. Return completed relevant forms to the Iowa Department of Transportation, Contracts, Design or Construction and Materials Bureaus, 800 Lincoln Way, Ames, Iowa 50010 for review and processing. Annually you will be required to submit an Affidavit of Continued DBE Certification Eligibility Form, a No Change Affidavit, and all supporting documentation.









Although your firm is now certified as a DBE with lowa DOT and listed in our DBE Directory; in order to be eligible to be utilized as a DBE to meet the DBE participation goal on federally funded projects let by lowa DOT, your firm must be listed in the Bin File as an eligible DBE in Bid Express. Iowa DOT projects are generally let on the third Tuesday of the month, but a newly certified DBE has to have been added to the DBE Bin File by the third Monday of the month BEFORE the letting in order to be eligible to be used as a DBE to meet the DBE participation goal.
