NOTES TO FINANCIAL STATEMENTS

September 30, 2023

1 - Nature of Business

Gawad Kalinga Canada was incorporated on October 6, 2010 and was registered as a charitable organization on July 25, 2011.

The Organization's main purpose is to help eradicate poverty and restore human dignity by providing free housing and shelter, education, feeding programs and disaster relief.

2 - Basis of Accounting

The accounting policies of the Organization are in accordance with the Canadian accounting standards for not-for-profit organizations (ASNPO).

Assets are recorded at historical cost. Liabilities, income and expenses are recognized based on accrual accounting.

Revenue Recognition

The Organization follows the deferral method of accounting for donations and donordesignated donations. Donations are recognized as revenue when the amount is received unless deferred for specific future use.

Donated Services

The Organization relies upon the contributed services of volunteers. Since these services are not normally purchased by the Organization and because of the difficulty in determining their fair value, donated services are not recognized in these financial statements.

3 - Deferred Revenue

The account represents donations deferred for future use and generally for projects specifically supported by donors.
