## REALM OF CAREGIVING RESPONSIBILITIES

At Home Care caregivers are expected to provide the highest quality of cleaning and service possible to all clients. If there is any reason to believe that quality cleaning is not being provided, additional training on caregiving will be required. The following duties are tasks. Which a client may ask you to perform. Some of these duties may be performed on a regular schedule, or only periodically. However, all are certainly part of the caregiver's duties if a client asks for the task to be completed. All duties are to be performed inside the home living areas. Caregivers are not allowed to shovel snow, rake yards, clean flower beds or gardens, etc. garages and unfinished basements are not generally considered living areas unless otherwise included in the agreement. The following is not inclusive of duties which may be included in a client's plan.



## OUR SERVICES

At Home Care will provide non-medical services in the home or place of residence of the client; such as but not limited to the following as part of the plan of care

### **\*Personal Services:**

- assist the client with the activities of daily living such as bathing, dressing and feeding.

### **\*Personal Care:**

- provide non-medical assistance and services to the client in accordance with the physicians or nurses instructions

### **\*Household Services:**

- assist clients with meal preparation, permitted personal shopping activities and errands, light housekeeping, personal laundry, cooking, assistance in getting to and from appointments and also companionship.

### **\* Record Keeping:**

- assist the client in the maintenance of household records.
