veterinary care for their entire life.

2. **No Transfer Without Consent** – The adopted animal may **not** be sold, rehomed, given away, or transferred without the **written consent of Scruffy's Sanctuary Inc.™**. If you are unable to keep the animal for any reason, they must be returned to Scruffy's Sanctuary Inc.™.
3. **Veterinary Care** – You agree to provide routine and emergency veterinary care, including vaccinations, parasite control, spay/neuter (if not already done), and annual wellness exams.
4. **Follow-Up Checks** – Scruffy's Sanctuary Inc.™ reserves the right to conduct follow-up home visits after adoption to ensure the animal's well-being.
5. **Yearly Updates** – You must provide Scruffy's Sanctuary Inc.™ with **updated photos and proof of veterinary care once per year** for the lifetime of the animal.
6. **Right of Recovery** – If evidence of neglect, abuse, or failure to comply with this agreement is found, Scruffy's Sanctuary Inc.™ reserves the right to reclaim the animal immediately.
7. **California Law Compliance** – Adopters must comply with all state and local animal welfare laws, including licensing, vaccination, and spay/neuter ordinances.
