BYLAW NO. 03/17

Resort Village of Bird's Point

A BYLAW TO PROVIDE FOR ENTERING INTO AN AGREEMENT RESPECTING THE RESORT VILLAGE OF WEST END'S USE OF THE TRANSFER STATION

The Council of the Resort Village of Bird's Point in the Province of Saskatchewan enacts as follows:

1. The Resort Village of Bird's Point is hereby authorized to enter into the agreement attached hereto forming part of this Bylaw, and identified as "Attachment A", with the Resort Village of West End for the purpose stated within the agreement.
2. The Mayor and the Administrator of the Resort Village of Bird's Point are hereby authorized to sign and execute the attached agreement identified as "Attachment A".
3. This agreement will come into effect and come into force on the date in which both parties sign.

 a municipal corporation in the Province of Saskatchewan

and: the Resort Village of West End
 a municipal corporation in the Province of Saskatchewan

Whereas:

1. The Resort Village of Bird's Point owns and operates a Transfer Station;
and
2. The Resort Village of West End wishes to enter into an agreement for their resident's use;
and
3. The Resort Village of West End residents shall be charged an additional charge based on their items to be dumped at the transfer station.
and
4. The parties wish to enter into an agreement for an annual fee for service for fixed costs.

Now, therefore, this agreement witnesses:

SECTION 1: TERMS OF AGREEMENT

1. This agreement shall of force and effect from the effective date.
2. The residents of the Resort Village of West End shall pay an additional charge based on their items to be dumped at the transfer station as shown in Attachment "B".
3. The annual fee for services shall be a flat rate of \$1500.00.
4. The fee will be reviewed annually.

SECTION 2: GENERAL

1. This agreement to take effect on _____ day of _____, 2017.
2. This agreement may not be modified or amended except by an instrument in writing signed by both Parties hereto or by their successors or assigns.
3. This agreement shall be binding upon and ensure to the benefit of the parties, their respective successors and representatives.
