BYLAW NO. 08-21

A BYLAW TO PROVIDE FOR ENTERING INTO A FINANCIAL AGREEMENT to purchase lands adding to the Resort Village of Bird's Point and withdrawing from the Rural Municipality of Fertile Belt No. 183.

ANNEXATION APPLICATION APPROVED BY THE MINISTRY September 17, 2021

The Council of the Resort Village of Bird's Point in the Province of Saskatchewan enacts as follows:

1. The Resort Village of Bird's Point is hereby authorized to enter into the agreement attached hereto forming part of this Bylaw, and identified as "Attachment A", with the Rural Municipality of Fertile Belt No. 183 for the purpose stated within the agreement.
2. The Mayor and the Administrator of the Resort Village of Bird's Point are hereby authorized to sign and execute the attached agreement identified as "Attachment A".
3. This agreement will come into effect and come into force on the date in which both parties sign.

ATTACHMENT "A"

This agreement made this 12th day of October 2021.

Between: the Resort Village of Bird's Point
a municipal corporation in the Province of Saskatchewan

and: the Rural Municipality of Fertile Belt No. 183
a municipal corporation in the Province of Saskatchewan

Whereas:

1. The Rural Municipality of Fertile Belt and The Resort Village of Bird's Point have altered their boundaries as approved by The Ministry September 17, 2021;
- and
2. A Financial agreement was made between the RM Fertile Belt no. 183 and The Resort Village of Bird's Point to complete the annexation;
- and
3. The parties wish to enter into an agreement for the financial terms of the approved annexation.

Now, therefore, this agreement witnesses:

SECTION 1: TERMS OF AGREEMENT

1. The Resort Village of Bird's Point agrees to pay to the RM of Fertile Belt No. 183 the amount of \$42,000.00 for acquisition of property completed in the Annexation approved September 17, 2021.
2. This amount to be paid in six equal installments of \$7000.00 each, interest free, to be paid on or before December 1 of each of the six years.

SECTION 2: GENERAL

1. This agreement to take effect on 12th day of October, 2021.
2. This agreement may not be modified or amended except by an instrument in writing signed by both Parties hereto or by their successors or assigns.
3. This agreement shall be binding upon and ensure to the benefit of the parties, their respective successors and representatives.
