

BYLAW NO. 06-23

A BYLAW OF THE RESORT VILLAGE OF BIRD'S POINT TO ESTABLISH A LICENSE FEE FOR RECREATIONAL VEHICLES/SEASONAL TRAILERS/PARK MODELS ON TITLED LOTS IN THE R1, R2 and R3 RESIDENTIAL DISTRICT, and PRIVATELY-OWNED PARCELS IN THE PARKS AND RECREATION DISTRICT AND LOCAL COMMERCIAL LOTS/PARCELS (excluding Private Campgrounds) AT THE RESORT VILLAGE OF BIRD'S POINT.

The Council of the Resort Village of Bird's Point in the Province of Saskatchewan enacts as follows:

1. Recreational Vehicles/Seasonal Trailers/Park Models placed within the boundaries of a titled lot that is NOT developed with any Primary Residence shall obtain a license permit (form A attached to this Bylaw) for the year from the Administrator of the Resort Village of Bird's Point, within seven (7) days of arrival. Permits to be applied for annually Prior to June 1 of each year. Maximum two RV Vehicles per vacant lot (A lot where no improvements are currently built)
2. The license permit fee for the year shall be \$650 per trailer payable to the Resort Village of Bird's Point.
3. Owners of a titled vacant lot who, **occasionally for a few days only, no longer than two (2) weeks** per calendar year place a recreational vehicle/seasonal trailer and remove said recreational vehicle/ RV/trailer/park model after no more than two (2) weeks from the lot will be exempt from the license fee.
4. This bylaw shall come into force on third and final reading.
5. Bylaw #11-22 is hereby repealed.

- Is situated within the required set-backs of the property
- Recreation vehicle/seasonal trailer must be well maintained and in good condition
- Trailer must be licensed and not used for rental or for permanent human habitation
- No permit allowed without appropriate sewer, water and power services
- No additions or structural alterations to trailer allowed
- Recreational vehicle/trailer accessible and mobile at all time and not permanently secured on lot
- Decks or sheds will be considered an accessory use and could require a building permit
- Licensing permit fee of \$650. for the year and to be renewed annually

If permit is not approved the recreation vehicle/seasonal trailer has to be removed within 48 hours. (If not removed all cost fees associated with the removal and storage is the responsibility of the owner).
