I hereby acknowledge that I understand that permission to begin building is not granted to me until a Building Permit (Form B to Bylaw No. 1-2012), signed by the Building Official or Secretary is returned to me.

I hereby agree to comply with the Building Bylaw of the local authority and acknowledge that it is my responsibility to ensure compliance with the Building Bylaw and Zoning Bylaw of the local authority and with any other applicable bylaws, acts and regulations regardless of any plan review or inspections that may or may not be carried out by the local authority or its authorized representative.

The owner shall indemnify and save harmless the Resort Village, the Building Official or any municipal official or employee from all losses, costs, claims or damages whatsoever brought by or on behalf of the owner or any other person that may arise as a result of, from, or in any way touching upon the issuance of the permit related to the work, and not to limit the generality of the foregoing, in relation to: the fact that a building, or the placement, erection, construction, alteration, repair, renovation, reconstruction, demolition or removal thereof authorized by permit, does not comply with the regulations of this Bylaw or any other Bylaw of the Resort Village, federal or provincial act, regulation or code or derogates from a right of any other person; faulty subsoil conditions, whether such conditions were unknown to the Resort Village or not, the fact that the owner or any other party on behalf of the owner has continued to work so as to conceal previous work, making that work impossible to inspect by the Resort Village or any other municipal official or inspector appointed by the Resort Village; or the owner's failure to call for an inspection of work as required in the Act and regulations.
