Solicitor Report:

Attorney Smith reported to Council about a letter sent to Honesdale National Bank regarding the intention of Browndale Fire Company to purchase a fire truck. The letter stated that this company is our agent and that they did inform Council of their decision to purchase this vehicle.

The amendment to the ordinance regarding weigh restrictions on Peterlin Drive was advertised to change wording from 10,000 pounds to no greater than five tons. Mr. Mayers made a motion to accept the ordinance, second by Mr. Matos. Motion carried with all in favor.

Committee Reports:

Mr. Mayers stated that engineering estimates are necessary for the storm drain projects and there may be some additional funds needed for paving on 2nd Street.

Mr. Mayers also informed Council that there were two questions received regarding the stormwater permit verifying a location and acknowledging the pubic announcements.
