All agreed that Mayor Brady would run the meeting.

Mr. Matos, second by Mr. Mayers motioned to approve the expense report. Motion carried with all in favor.

<u>Mayor Report:</u> Mayor Brady noted that he will be attending the PA Mayor's Conference in Pittsburgh from July 15<sup>th</sup> through July 18<sup>th</sup>. He further noted that a couple living at 306 Sixth Street spoke with him about their wedding which they are having at their home. They requested permission to have vehicles parked in

the Vandling Park and they will shuttle guests to eliminate congestion. Mayor Brady agreed that this was a good idea.

**Solicitor Report:** Attorney Levine had nothing to report at this time.

### **Committee Reports:**

John Carachilo noted that he had a proposal from T.E. Spall to install air conditioning at the Borough Building. The funds would come from the remainder of the COVID grant and the new ARPA grant. Mr. Mayers questioned if he had obtained three estimates. This is required under the new bid process.

John Mayers reported that there was no mine subsistence at Ash & Hillside, but two adjacent storm drains with one having fallen into the hole. The solution would be to replace the two drains with one and he has asked KBA to provide a specification to replace it. Mr. Matos stated that it is on private property. Mr. Mayers requested that Attorney Levine review the matter to see if is our responsibility as it is a storm sewer system.

Mr. Mayers further reported that patching is complete on Ash Street. Additional work to seal the seams should be completed this week. The issue with trash collection for Mr. Stanton has been rectified.

Mr. Mayers noted that the new zoning board met on June 9<sup>th</sup> with three new members present. They reviewed some of the documentation related to their position.

Mr. Mayers contacted PA Dot and they will take care of the cinders along Main Street.

In regard to the ARPA grant, Mr. Mayers stated that the Borough has \$28K in general fund for Peterlin and he would like to not use those funds. The Mayor and Mr. Carachilo are still trying to obtain grant funding to pave all Borough streets. There was some further discuss on the Peterlin sewer project, Stafursky and concerns with KBA.

### **Unfinished Business:**

Bills received from Dave Seaman of 319 Main Street were discussed in relation to a sewer backup on March 22<sup>nd</sup>. The bills include payments for repair of approximately \$5800. Mr. Seaman stated that he tried to contact Borough Council members at the time of the incident but no one was home. Mr. Matos stated that he unplugged the sewer line in July of 2020 and the blockage was on Mr. Seaman's property between the clean out and the sidewalk. Attorney Levine stated that the matter needs to be investigated to see if the Borough is responsible. Mr. Mayers agreed that we need more information. According to Mr. Seaman, a blockage in 2018 was in the main according to Roto-Rooter, July 2020 was in his yard, and in March of 2021 was in the main according to JS Wright. Mr. Mayers questioned if we should turn it in to our insurance and that Attorney Levine should review.

Mr. Carachilo, made a motion to turn the matter over to our insurance carrier. Mr. Carachilo seconded the motion. Motion carried with Mr. Carachilo and Mr. Mayers voting yes and Mr. Matos abstaining.

In other unfinished business, Attorney Levine has the animal ordinance to work on and the NEIC contract to review. The acceptance of the written bid process is on hold.

### **New Business:**

Mr. Carachilo, second by Mr. Mayers motioned to authorize the Secretary to submit the grant request to DCED for the ARPA grant and for Council President Fran Pantzar to sign any required documents. Motion carried with all in favor.

#### **Public Comment:**

Krista Tomazic addressed Council and requested to view the complaints that Mr. Lavin has about her chicken coop. Attorney Levine replied that she would have to submit a right-to-know request. She further noted that the location of the chicken coop was approved by the Borough and that no one else is complaining about it. She believes the complaint from the neighbor in regard to foul odors is coming from feral cats.

Mr. Mayers questioned if the coop meets the required setback of 20' or 5' with permission from the neighbor. Ms. Tomazic replied that she could not place the coop 20' from any property line and at the time the neighbor verbally told Mr. Lavin that the coop was okay where it was located. Mayor Brady stated that the ordinances must be enforced on all property owners the same. Ms. Tomazic agreed with the Mayor but also stated that the lot size would not allow for twenty feet. Mr. Mayers agreed and stated that whoever owns chickens has to abide by the ordinance. Mr. Matos noted that the problem is that she did get permission and with permission she would be abiding by the ordinance.

Mr. Matos commented on four dogs continually in his yard and the feral cat problem. Attorney Levine is reviewing the ordinance.

The meeting was adjourned at 7:55 PM on a motion by Mr. Mayers, second by Mr. Carachilo.
