Mr. Boyle commented that he and Mr. Pantzar attended the Forest City/WVIA "Our Town" meeting. Fran requested that the FC News (Trish) put out that Council would like to see Vandling residents, both current and former, involved with the project to offer their thoughts and ideas. Trish stated that everything is postponed for now due to the virus. It was stated that older residents would have a lot to offer the program. WVIA was very complimentary and impressed by the turnout. They are including Vandling and Browndale into the documentary noting it is the area where three counties intersect.

New Business:

Ordinance #1 of 2020 regarding permit requirements was reviewed and approved on a motion by Mr. Boyle, second by Mr. Matos. Motion carried with all in favor.

John Carachilo asked for an update on the Peterlin project and KBA. The project should be advertised this week with bids opened in April.
