Mayor Report: Mayor Prince wished everyone a Happy New Year. He noted that the Borough has been approved to be on the list for DCNR and DCED grants making us eligible for the program. Mayor Prince also noted the water runoff issue between 7th and 5th Streets. Mr. Carachilo stated that Andy Gorel (Fell Township Supervisor) is going to try to get the backhoe in to open the ditch farther down which will help alleviate the problems.

Solicitor Report: Attorney Levine had nothing to report at this time.

Committee Reports:

Mr. Carachilo met with Lackawanna County Commissioners last Thursday regarding funds needed for the Borough. He will be meeting with Economic Development Manager Brenda Sacco shortly. We need to confirm the number of miles of roadway in the Borough as he has requested funds for paving as well as equipment purchase such as a pickup truck with a plow. (Liquid Fuels estimate of miles is 2.02). Mr. Carachilo plans to meet with Ms. Sacco within the next ten days and he invited Mrs. Serge to join him if she is available during the day.

Bill Matos and Carbondale Police are aware of recent issues with catalytic converters being stolen and they are actively investigating the matter.

Kathy Murnin questioned why it took so long for her building permit to come through. NEIC did not bill her until December and the roof was completed in May. It was questioned why the contractor didn't file it in May.
