Mrs. Sullivan motioned to pay the bills, second by Mr. Matos. Motion carried with all in favor.

*Mayor Report:* Mayor Prince questioned if we have an existing ordinance for keeping chickens. We do.

**Solicitor Report**: Attorney Levine had nothing to report at this time.

## Committee Reports:

Mr. Carachilo reported that he went to the Lackawanna County offices to file the \$5,000 application approved by Council last month. The commissioners are expected to approve it in June. He also went on March 1<sup>st</sup> to see about getting dirt for the field. This request will go before a committee and should be approved in a shorter time frame.

He met with the engineer last week and explained what needs to be done for paving. Lackawanna County will be conducting income surveys to verify eligibility for these project areas.

## <u> Unfinished Business:</u>

Mr. Pantzar noted that there was no point in putting off the payment to Rock Bottom as it was a legitimate expense for additional work that needed to be completed. Mr. Pantzar made a motion to pay the \$2600 balance. Mrs. Sullivan seconded the motion. All were in favor.

In regard to the Lackawanna County Hazard Mitigation Plan Agreement/Representative; Mr. Pantzar, seconded by Mrs. Sullivan approved the plan agreement and John Carachilo will be the Borough representative. Motion carried with all in favor.

Mr. Carachilo suggested we move forward and order the dirt for the field as he is confident the County will pay for it. Mr. Pantzar, seconded by Mr. Matos made the motion to approve the purchase. Motion carried with all in favor.

### <u>New Business:</u>

Fran noted that he spoke with the Brennan's and they are ready to move forward in obtaining Borough approval of their plans. It was agreed to schedule a special meeting for April 3<sup>rd</sup> at 7 PM to review the matter. Council requested Attorney Levine be present.

### <u>Public Comment:</u>

Willis Bell of 566 Main Street addressed Council about issues with 572 Main Street. The property has structural problems, soffit and the back deck are falling off. He has found used needle on the property and the Constable has been there to evict the residents.

Mr. Lavin noted that NEIC inspected them and they all failed. They have thirty days to repair but there has been no response. Mr. Pantzar stated that he will get together with Mr. Lavin and start the process to take care of it.

Mr. Bell also offered to help the little league with the dirt distribution.

Krista Tomazic who lives in the same area of Main Street also spoke about the feral cats and constant police presence. They are feeding the cats which is growing the population. Mr. Carachilo said the police activity has led to many reports and fines.

Brian Fitzsimmons thanked Council for their efforts with getting the field ready for little league.

Kathy Murnin asked if the field would be used for practice or games. It will be both. It was mentioned that the recreation board building is available for use. The soccer league used it as well.

The little league will put a port-a-lav at the field. A locking gate would be helpful to keep vehicles out. A combination lock could be installed with the code given to the coaches.

Mr. Carachilo will follow up with Chief Bognatz about these concerns.

The meeting was adjourned at 7:40 PM on a motion by Mr. Matos, second by Mr. Pantzar. All in favor.
