It was noted that we would pay the Lawn Doctor but going forward the league should be responsible for this expense. Mrs. Serge, second by Mr. Pantzar motioned to approve the current expenses. Motion carried with all in favor.

<u>Mayor Report:</u> Mayor Prince asked Mr. Pantzar what progress has been made on the purchase of new Christmas decorations. The Mayor would like to check with the County about parks and recreation funds to see if they might be available for this project. Mr. Pantzar stated that he would like to have Mrs. Serge assist with project.

The Mayor stated that the County has funds available for parks and recreation and that they have questioned why we aren't utilizing them. It was noted that we need to raise funds for parks and recreation. Mr. Matos noted that years ago we had a parks and recreation department that was disbanded as they were mostly elderly residents volunteering their time. Mr. Pantzar stated that he thinks we should work as a committee of Council for this effort.

Solicitor Report: Attorney Levine had nothing to report at this time.

Committee Reports & Unfinished Business:

Mr. Pantzar reported on the bids that were opened at the last meeting and noted that the base bid did not include a section of Clinton Street. He reported on the sections of streets included and that after review they eliminated a section of Hillside and added Clinton. We will hold off on speed bumps on Hillside.

Mrs. Serge asked if we have heard from Stafursky about Peterlin. They will be coordinating with Linde to get all the paving completed.

Mrs. Serge also signage on Hillside from Richmondale. There is some confusion in noting both Richmondale and Vandling. Mr. Pantzar stated that there should be a sign regarding trucks in this area. Mr. Matos stated that we should relocate the sign to lower on Hillside.

New Business:

Public Comment:

Mark Cordelli from Lackawanna County shared numerous resources for upcoming events that will be shared on the Borough's Facebook page. Mayor Prince questioned if the County will be sponsoring any type of child friendly fall event. Mr. Cordelli said there may be something in the works.

Kathy Murnin reported that the drain across from Wearing property is open and there is a grate in place but there is a large hole opening and eroding around it. It was noted that this may have to be dug out and a catch basin installed.

Mrs. Murnin also stated that in regard to the new development that the trees are gone and much of the area dug up; however Billy (?) has been maintaining and weed whacking the area and she feels he should be paid for his services. It was also stated that some roots have to be dug up with special equipment. It was noted that this is a right-of-way for utilities and not part of lot #28.

The meeting adjourned at 7:45 PM on a motion by Mr. Pantzar, second by Mrs. Serge.
