Contract, Terms and Conditions

"You" - The customer

"We" - ASD Italy Marche Motorbike Tours

"Tour" - The ride, holiday, tour you have selected

1. INSURANCE

Our insurance covers Third Party and Public Liability.

It is your responsibility to provide your own valid Travel Insurance.

In the event of an accident, you **MUST** produce your own emergency medical insurance details, or will otherwise be classified as a "private patient".

2. DOCUMENTATION

You must bring your valid **DRIVING LICENCE**, **PASSPORT**, and/or **IDENTITY CARD** plus any other documentation relevant to motorbike riding. If stopped, the Police will require you to produce these.

3. RISK & RESPONSIBILITY

Your participation in the Tour is entirely at your own risk.

Pillion passengers ride at their own risk, and are the responsibility of the riders.

* It is your responsibility **NOT** to travel or participate against medical advice.

If you have a medical condition, or take medication that could affect your capacity to ride, please **DO NOT** participate.

* It is your responsibility to be fit to ride.

You must admit to experiencing **ANY** impairment from alcohol, drugs, stimulants or medication, including ongoing effects from the previous night.

Italy Marche Motorbike Tours is entitled to breathalyse you before allowing use of our motorbikes.

Should your physical or mental capacity be questionable, you will NOT be permitted to ride.

IMPORTANT

In the event of an accident, should the Police find you to be under the influence of alcohol or drugs, YOU :

- * violate your Contract with ASD Italy Marche Motorbike Tours
- * invalidate our insurance with you
- * are 100% responsible and liable for ALL costs/damages to ALL persons, vehicles, premises sustaining injury and/or damage.

ASD ITALY MARCHE MOTORBIKE TOURS are NOT responsible or liable for:

- * Any injuries you incur, whether minor, severe, critical or fatal
- * Any loss of/damage to your property or possessions, irrespective of how this occurred
- * Your conduct as a rider. Please ride in a safe, considerate and respectful manner, without endangering other road users
- * traffic, road conditions or weather
- * death, personal injury or illness incurred by your participation in activities outside our itinerary

CLAIMS

We are NOT responsible for:

- * claims for accident, injury, damage or shock to you and/or your pillion passenger

You CAN NOT make a claim against any landlord/proprietor, business and/or its' employees or their insurance companies for any physical or mental damage you may suffer as a result of use of our vehicle.

WELLBEING & SAFETY

It is your responsibility to advise us, BEFORE the start of the Tour, should any of the following be relevant to either you or your pillion passenger:

- * illness
- * infirmity
- * allergies
- * dietary requirements

DURING THE TOUR

Both you and your pillion passenger are responsible for:

- * Abiding by instructions and directions given by us, in consideration of the health and safety of both you, and others.
- * NOT endangering anyone connected with ASD Italy Marche Motorbike Tours or behaving in a manner likely to cause personal injury, loss or damage to our property, personnel or customers.
- * Riding safety, in a courteous, respectful manner.
- * Adhering to the prevailing speed limits, road signs and regulations of the road.
- * Riding within the legal requirements of Italy. We will NOT be responsible for any violation of said requirements.

CANCELLATION

Should ASD Italy Marche Motorbike Tours cancel your Tour, we will offer:

- * alternative Tour dates, or
- * refund monies not spent/used or utilised paid out so far.

We are NOT responsible for the following situations, and will therefore not offer refund or compensation in the event of:

- * war
- * riots
- * civil unrest
- * terrorism

* natural disaster

Or for any unforeseen cancellations due to:

* industrial action

* weather

ASD Italy Marche Motorbike Tours are NOT obliged to refund any money should YOU cancel your holiday, or withdraw from the Tour for any reason.

LOSS/THEFT

You will accept full responsibility for the theft of the vehicle (and/or any of its' components), and pay up to a maximum of £1000.

The rider must pay for any damage caused to the vehicle (if it is their fault)

up to a maximum of £1000.

By signing this Contract, you declare yourself:

* a competent rider

* to have the ability/capability, finances and/or insurance to be

able to return both yourself and your pillion passenger home, in the event of an accident or emergency.

* In possession of a valid motorcycle license, to ride motorbikes over 500cc.
