#### **New Business:**

### 1. Authorization to sign payroll checks:

# 2. Potential annexation of Harris Landowning and GVC property into the District:

Travis Laviolette requested the Board consider annexing Harris Landowning field 201 and Chairman Hulbert said he'd received a request from Green Valley Corporation to annex their land (APN# 012-170-013) into the District as well. After hearing both requests, the Board said they would fact find with MBK Engineers to see if it's possible to annex this property into the District and agenize this matter for the May Board meeting.

### 3. Deadline to pay for District water:

District Manager Terry Bressler requested the Board approve April 30<sup>th</sup> as the deadline to pay for District water allocations and if the water isn't paid for by April 30<sup>th</sup> there will be no water and there will be no refunds on this one time water allocation.

The Board agreed to the above request.

#### 4. 2021 Water Sale:

Terry said the land that is being idled for the water sale cannot have any weeds and no water from any source can be put on the land from May 1<sup>st</sup> through September 30th. The grower has to certify the land was planted in rice in 2020.

David Barale asked how the District can say how the landowners can use their leftover water. He said if its allocated water what makes the difference. Chairman Hulbert said the water used later in the year becomes expensive to the District. Terry Bressler said last year it was an additional cost of \$80,000. David said he feels the habitat flood up is a separate issue from his. Terry said he would stay with the Bureau of Reclamation date of September 30<sup>th</sup>.

#### **Chairman's Report:**

Chairman Hulbert said there's a lot going on with the Sacramento River Settlement Contractors, salmon studies and water sales etc. He said SRSC paid their share of the voluntary agreement and joint defense. One area he has been watching is a letter to Department of Water Resources Control Board regarding the NRDC litigation. The letter request SWRC Board take immediate action to address perceived threats regarding the salmon in the Sacramento water shed from the Central Valley project. SRSC wrote a letter to SWRCB on all the points saying you can't do what NRDC wants you to do as this is critical. SRSC paid NCWA fees to deal with all this ongoing matter. He said there's a lot going on right now to follow.

### **Managers Report:**

Terry said he has two wells running at the north end of the District. Princeton Pumping facility is not running at this time.

He said he'd received copies of the Drumheller water right information for the District archives from Jack Baber and Glenn Wellborn.
