FOOD RECOVERY. Pete's Garden recovered and distributed approximately 6100 pounds of healthy prepared foods in 2021. Recovered food consisted of 50% prepared proteins, such as grilled chicken, grilled beef and turkey burgers, and meatballs, 10% prepared vegetables, 15% prepared starches such as mashed potatoes, roast potatoes, and cooked rice, and 25% mixed items such as soups and casseroles containing mixed ingredients. Recovered food was distributed through ten different social service agencies that serve food-insecure families.

SPONSORED MEALS. Pete's Garden distributed approximately 40,000 heat-and-serve meals in 2021. Each meal consisted of one serving of meat or plant-based protein and 1-2 servings of vegetables and/or starch. Meals were distributed through ten different social service agencies that serve food insecure families.
