
IT IS ORDERED THAT:

AGREED ORDER

People by Ken LaRue, Assistant State's Attorney;

Marni Yang by her attorney, Jed Stone;

IT IS ORDERED:

The Deerfield police shall make available for examination, photographing and inventory by Ms. YANG's attorneys, Stone & Associates, Ltd., or their investigator, Perry Myers, all evidence collected in the homicide investigation of Rhoni Reuter, including but not limited to the following:

1. The video of LeRoy's Barber Shop, evidence number CAF 006;
2. The video of Shaun Gayle's alleyway, evidence number DT 011;
3. Rolls of film from the crime scene, rolls 1 thru 8, evidence number CAF 001;
4. Recordings of police radio traffic between officers and dispatch who responded to the scene;
5. A brown leather purse and contents, evidence number JY 016;
6. Door knobs as follows:
 - a. Inside living room door knob, evidence number DT 008;
 - b. Outside kitchen door knob, evidence number DT 009;
 - c. Inside kitchen door knob, evidence number DT 010;
 - d. Outside living room door knob, evidence number DT 007

These door knobs are also found as NIRCL item numbers 24, 25, 26 and 27.

Said items shall be tendered to Perry Myers, Stone's investigator, to be transported to Larsen Forensics in Glen Ellyn, IL for testing and returned to the Deerfield Police Department by Myers, maintaining a documented chain of custody.

IT IS ALSO ORDERED that the state shall make a Rule 417 disclosure to the defense without unnecessary delay.
