A RESOLUTION ADOPTING A REGIONAL COMPREHENSIVE PAN
UPDATE FOR THE CJERP PLANNING COMMITTEE

WHEREAS, in 2004, Chestnuthill, Jackson, Eldred, and Ross Township formed a Regional Planning Committee by entering into an Intergovernmental Agreement; and

WHEREAS, in 2012 Polk Township joined the Regional Planning Committee and began the process which resulted in the adoption of the 2015 Regional Comprehensive Plan; and

WHEREAS, in 2025 CJERP initiated an update to the CJERP Comprehensive Plan to ensure that the region's shared vision remains current and responsive to present day conditions; and

WHEREAS, CJERP engaged a professional consultant, Strategic Solutions, to work with CJERP to prepare an update to the Regional Comprehensive Plan; and

WHEREAS, such plan has been prepared and recommended for approval by the participating municipalities; and

WHEREAS, the Pennsylvania Municipalities Planning Code ("MPC") 53 P.S. § 10302 (b) provides in pertinent part, that a Multi-Municipal Comprehensive Plan may be amended in whole or in part following the conducting of at least one Public Hearing; and

WHEREAS, the MPC 53 P.S. § 10302 (c) further provides that an amendment to a Comprehensive Plan may be adopted by a majority vote of no less than a majority of all the members of the governing body; and

WHEREAS, as mandated by the MPC, a Public Hearing was held on July 23, 2026, at 7 pm at the Jackson Township Fire Hall, Reeders Pennsylvania, pursuant to Public Notice as defined in the MPC; and

WHEREAS, the Notice of Public Hearing specifically stated that a special meeting of each participating Board of Supervisors would be held immediately after the Public Hearing for the purpose of adopting the updates to the Regional Comprehensive Plan by Resolution; and

WHEREAS, the Board of Supervisors of Ross Township believe that it is in the best interest of the health, safety, and welfare of residents of Ross Township to adopt the update to the Regional Comprehensive Plan as prepared by the CJERP consultant.

NOW THEN BE IT RESOLVED this 23rd day of JULY 2026 that the Ross Township hereby adopts the update to the CJERP Regional Comprehensive Plan dated July 23, 2026 which is fully incorporated herein by this reference.

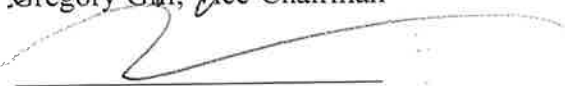
