North Council December Meeting Discussing Halibut Regs for 2022; ABM Trawl Bycatch in the Bering Sea;



The North Council is meeting remotely this week, with a decision on what options for guided angler halibut regulations will be forwarded to the IPHC. Abundance Based Management for halibut bycatch in the Bering Sea trawl fishery is up for action.

Hundreds of commenters submitted their arguments for and against reduced levels of halibut mortality in the Amendment 80 trawl sector, and delivered hours of oral testimony

at the meeting of the Council's Advisory Panel last week. and the full Council meets next week.

Future meetings:

• The Charter Halibut Management Committee is scheduled to meet Dec 6, 2021

- (virtually) to review ADF&G analysis of predicted charter halibut harvest and provide final recommendations of 2022 management measures.
- The <u>North Council</u> and its Advisory Panel will meet Dec 6-16, 2021 and will receive the Charter Halibut Management Committee report and provide recommendations to the IPHC.
- The IPHC will hold its Annual Meeting Jan 25-29, 2021
- The Council is tentatively scheduled to review the Final Draft of the RQE funding analysis and the Catch Sharing Plan Allocation Review at the February meeting (Jan 31- Feb 8, 2022).

IPHC Interim meeting Nov 30 – Dec 1:

The Halibut Commission met for its <u>Interim Meeting this week</u>. Dr. Ian Stewart reported some encouraging news abut the <u>status of the stock</u>: the promising 2012 year class is entering the directed fisheries and continues to grow at a faster rate (by weight) than other year classes. It is starting to look like the cohorts of halibut that drove the directed fisheries to success in the 90s. It's too early to count these fish as proof of a recovered fishery, Dr. Stewart advised, because ocean conditions can slow things down if they change. Ocean temps in the Bering Sea are exceptionally cool this winter, and the provisional numbers of fish available in 2022 are looking better than last year.

The results from 2021's season registered overages in the guided angler sectors in 2C and 3A. The regulations were built on the high uncertainty of pandemic-era effort levels. The Charter Halibut Committee meets this week to put finishing touches on the range of options delivered to the Halibut Commission early next year.



AK Legislative Hearing on Trawl Bycatch:

Fish & Game Commissioner Doug Vincent-Lang, NOAA Fisheries' Glenn Merrill, and North Council Executive Director David Witherell answered questions from Alaska state legislators in a <u>public hearing about how trawl</u> bycatch is managed in Alaska.

2 days after the hearing, <u>Gov. Dunleavy</u> <u>issued an order to form a Committee to investigate trawl bycatch</u>.

They will be appointing one charter rep to the Committee. Interested? Details here. The ACA board of directors discussed a nominee and have written a letter in support of board member Brian Ritchie for this panel. Brian is currently serving as a charter rep on the AP.

"The Bureau of Ocean Energy Management (BOEM) is



developing guidance to mitigate potential impacts from offshore wind projects on commercial and recreational fisheries and fishing. The first step in this process is to gain knowledge from the people and organizations that know and use these areas."

BOEM will host a series of workshops to aid in this effort. A workshop focused on marine recreational fisheries will be held on December 7th, - 10am EST - Recreational Fishing Workshop. Follow this link to Register.

BOEM will host a series of workshops during which BOEM will:
Present the purpose and intent of the 2014 document Development of Mitigation Measures to Address Potential Use Conflicts between Commercial Wind Energy Lessees/Grantees and Commercial Fishermen on the Atlantic Outer Continental Shelf.

Request input from the fishing community and developers that would inform the draft guidance on fisheries mitigation. Topics to consider include project siting, design, navigation, and access; safety; environmental monitoring; and financial compensation.

Congressional Watch: House Subcommittee Hearing on MSA - proposed changes to federal fishery laws.

On Nov. 16 the House Subcommittee took testimony on bills to reauthorize the Magnuson Stevens Act and other bills that affect fisheries. Western Alaska Tribes, suffering a prohibition on chum and reduced chinook salmon retention, seek halt to trawl bycatch. Ms. Mary Peltola, of the Kuskokwim River Inter-Tribal Fish Commission testified in favor of adding two seats on the North Pacific Fishery Management Council for tribal representatives to address the impacts of trawl bycatch, habitat loss and climate change. Rep. Huffman (D-CA) said there "will be no moratorium on bycatch" in response to concerns about changing language from "reduce bycatch to the extent practicable" to "reduce bycatch." (This language has always applied to all gear types, not just trawl.) Don Young & Dems support adding 2 seats on the North Council specifically for Alaskan Natives.

House Natural Resources Committee met Nov. 17 and voted to pass the legislation for the RQE. Next step is a hearing and vote in the Ways and Means Committee of the House.
