WHAT DOES EH CAPITAL GROUP INC DO WITH YOUR PERSONAL INFORMATION?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we are doing.

What?

The types of personal information we collect, and share depend on the product or service you have with us. This information can include:

- **Social Security number and Payment History**
- **Account balances and Transaction history**
- **Credit history and Overdraft history**

When you are no longer a customer, we continue to share your information as described in this notice.

How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons EH CAPITAL GROUP INC chooses to share; and whether you can limit this sharing.

What we do

How does EH CAPITAL GROUP INC protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secure files and buildings.

How does EH CAPITAL GROUP INC collect my personal information?

We collect your personal information, for example, when you

- Open an account or use your credit or debit card
- Pay your bills or Apply for a loan
- Make deposits or withdrawals from your account

We also collect your personal information from other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes – information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.
