## BRIDAL PARTY – WEDDING DAY INSTRUCTIONS:

- The entire bridal party should be present at requested arrival time and must be ready for their turn.
- Arrive with clean dry hair. Hair Dryers **will not** be available.

## TERMS:

- Before a wedding date can be reserved, a fully executed contract is required at time of booking. Credit card information must be obtained and a 50% non-refundable deposit is due.
- Any remaining balance is due & processed 14 days prior to your wedding date.
- \*A balance may be due on the day of services, providing any additional services and/or time has been added. (Every 30min needed over end-time agreed upon, will incur an additional charge of \$60. Consider time needed/wanted for veil adjustments.)
- All services must be paid by the Bride. Bride holds the responsibility for payment in full.
- Any changes made regarding this contract must be accepted by me in writing prior to taking effect.
- For insurance purposes, equipment and supplies stylists bring on site are for professional use only.
- All payments must be made in cash or credit/debit only. Checks are not accepted.
- Services scheduled on a Holiday or a Sunday will incur an additional charge of \$500.

## LATE ARRIVAL / NO-SHOW POLICY:

- If the contract cannot be fulfilled due to the clients tardiness, services may be cut short or surrendered. No credit will be given.
- If a bridal party member decides to forgo services on the day of, no credit will be given.
- If bridal party is more than one hour late without notification, the assumption is that the client is a no-show. In this case, the client forfeits all deposits and payments. No credit will be given.

## CANCELATION POLICY:

- The Bride must give no less than 30 days notice to be refunded all payments made **after deposit**. Any remaining balances owed will not be processed.
- If given 30 days or less notice, the remaining balance will still be processed and is non-refundable.
- In the event of a wedding being postponed, it will be treated as a cancellation unless the stylist(s) are available for the newly scheduled wedding date in which services will be provided as originally agreed upon.
