
National Trust for Historic Preservation Provides Webinar on Insuring Historic Properties



A vast majority of CHHCO membership are property owners of historic properties, and therefore the purpose of the Newsletter is to also convey information of interest to these property owners. Harriman's contact with the East Tennessee Development District (ETDD), Sarah Anderson, recently provided information for Harriman's Historic District property owners related to the challenges of property insurance. The 1 hour Webinar is available for public viewing through https://youtu.be/pE4Ton3nBOk where industry experts discuss the issues facing all property owners, not just of historic properties, related to risks within the insurance industry.



The Webinar explains the challenges faced by insurance companies where natural disasters are causing multi-billion dollar payouts per event, regardless of being designated Historic or not. In another segment, a property development expert also discusses the challenges of renovating historic properties whereby return on investment is impacted by renovation costs versus the market value.



Regarding insuring properties within Historic districts, it was noted the National Park Service does not create any stipulations on the insurer for replacement in kind in Historic Districts. While this is true, insurance companies may legally establish their own evaluation criterion whereby older homes, regardless of being in Historic Districts, have risks considered higher due to numerous considerations. companies when rating historic properties may therefore create an appearance of high insurance cost or denying insurance coverage, however these are market considerations the companies use when dealing with their exposure to large payouts. Be glad you don't live in a Historic home in the Florida Keys!



Great Progress on Interior during Month of July


I don't like to single anyone out at risk of offending someone else who deserves recognition for what they've contributed, however I need to recognize Pat LaDue's work on replacing a long-overdue section of rotted flooring. July was a very hot month, but we fortunately now have AC that makes working in that environment doable.



patch (pun intended) addressed constraint moving forward with sanding the floors. Pat worked during the week to salvage floor boards from the Sanctuary altar and (stage) area, reuse them as

flooring in the future conference room. The installation also required shims under the relocated floorboards to align them with the thickness of original floorboards.

With this necessary repair now behind us, we moved forward with sanding the floor surface. The design intention has been to refinish, but we



with polyurethane and leave the patina (variance in color) as-is.

The sanding took longer than expected, and we were able to only complete one room over the course of the day. Following the touch-up sanding, cleaning of surfaces in that room will proceed with the intention to polyurethane the floor then paint the ceiling and walls. The floor of the second room can proceed at any time now, and will be sanded during the August 24th workday if not sooner.
