Emergency Care. Should your dog become ill or injured during their stay at KPack, you grant permission for your dog to be treated by the closest emergency animal hospital and agree to pay Veterinarian fees for all services rendered. Every effort will be made within a reasonable and safe time frame to contact the owner, emergency contact, and current veterinarian prior to having your animal treated. We follow all safety precautions and will take immediate action if your dog is exhibiting symptoms of illness, injury, or life-threatening or contagious condition. We will address dogs with signs of sneezing, coughing, weezing, running eyes, vomiting, diarrhea, loss of appetite, canine distemper, parvo, rabies, etc.

Should your dog escape from our property while in our care, we will make every possible effort to get them back immediately by scouring the neighborhood, posting signs locally, and reaching out through local social media outlets. Please be sure your dog tags contain current owner contact information. K-Pack will also ensure your dog's safety by adding a tag with our direct contact information as well.
