The Company's website is an insurance e-commerce, news, and information platform. By using the Company's website, you consent to the data practices described in this Policy.

Collection of Personal Information

To provide you with suitable insurance products and services, the company may collect personally identifiable information, including your:

- Full Name
- Mailing address
- Email address
- Phone number
- Employment Information
- Other useful personal infom1ation

When you purchase the Company's products or services, we may collect your billing and credit card information in order to complete the transaction.

The Company may also collect anonymous demographic information, which is not unique to you such as your:

- Age
- Gender
- Race
- Religion
- Household information
- Other useful personal infom1ation

Please be informed that directly disclosing personally identifiable information or personally sensitive data through the Company' public message boards may be collected, used and shared with other partners and or third parties.

We do not collect any of your personal information unless you voluntarily provide it to us. However, you may be required to share certain personal details when using our products or services, such as:

- Registering for an account
- Entering a sweepstakes or contest we or a partner are running
- Signing up for special offers from third parties
- Sending us an email
- Submitting payment information to order and purchase our products and services

We will use your information to communicate with you about the services and products you have requested from us. We may also gather additional personal or non-personal information in the future.

Use of Personal Information

The Company collects and uses your personal information in the following ways:

- to provide and deliver the services you have requested
- to send you information, products, or services that you have asked for
- to update you about your account
- to fulfill the Company's obligations and enforce our rights under any contract between you and us, including for billing purposes

- for any other purpose with your consent

Sharing Information with Third Parties

The Company does not sell, rent, or lease its customer lists to third parties. In such cases, your personally identifiable information (email, name, address, phone number) will be shared with the third party.

Tracking User Behavior

Automatically Collected Information

The Company may automatically collect information about its users computer, including IP address, browser type, domain names, access times, and referring website addresses. Use of Websites Cookies

Security of Personal Information

The Company secures users personal information from unauthorized access, use, or disclosure. The Company uses the following methods for that purpose:

- SSL Protocol

To protect personal information (e.g., credit card numbers) transmitted to our website, we utilize encryption protocols like Secure Socket Layer (SSL). We strive to implement appropriate security measures to safeguard users' personal information against unauthorized access or alteration. However, no data transmission over the internet or wireless networks can be guaranteed 100% accurate. While we make every effort to protect users' personal information, users acknowledge that: (a) the internet has inherent security and privacy limitations beyond our control, and (b) the security, integrity, and privacy of all information and data exchanged between users and our site cannot be fully guaranteed.

Right to Delete Personal Information

Upon receiving a verified request from you, and subject to the exceptions outlined below, we will:

- Delete your personal information from our own records.

- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity, or identify and repair errors that impair existing intended functionality.
- Exercise the right of free speech, including that of another consumer.
- Comply with the California Electronic Communications Privacy Act.
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest.
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us.
- Comply with a legal obligation.
- Use your personal information only in a manner that complies with all applicable privacy laws.

Children Online Privacy Protection

The Company strictly adheres to the principles of the Children's Online Privacy Protection Act (COPPA), the GDPR, and any other applicable local laws regarding the collection of children's personal data.
