I hereby assume all responsibility and liability for such claims. I further relinquish all claims and agree to hold MVSV as well as all their members, officers, directors and property owners HARMLESS for loss or injury, which may have allegedly been caused directly or indirectly to my dog(s) or myself during participation in this event. I agree to hold HARMLESS MVSV, its members or agents for any act committed by this dog or any other dog in my possession.
