# Bishop Laurie's Christmas Message



On June 19, 2020 our granddaughter was born. She was born three months into the pandemic. Her parents were worried. Her grandparents were worried. It is challenging enough to be pregnant and give birth in the best of times but to give birth in the middle of a worldwide pandemic is an even greater worry. We worried about the unknown dangers this virus might present to the mother, the unborn baby, and the new born baby. Our worries kept us up at night. Our worries were relieved when she was finally born, perfect in every way. Our worry gave way to wonder-filled joy. Worry transformed to wonder as we looked back to see how God was holding and carrying them through the unavoidable worry. Our worry transformed to gratitude and wonder watching for what God would be up to next in her tiny life.

It's December 2022. We prepare to celebrate the birth our Lord Jesus. This Advent we come with our fears and worries too. We are living in the midst of challenging times in our country. The very foundation of our nation seems less stable. We each come with our own personal set of worries and fears about our families, health, finances, work, safety, the future...What is it that keeps you up at night? What are you worried about today?

Folks across our church are experiencing doubts and uneasiness about the future of their church. Does it keep you up at night? What are the threats to your church's future? How can the conversation move from fear and worry to wonder? As the miracle of Christ's birth is celebrated this season, we can move from worry to wonder. We wonder what God is up to now in this day and age. Together we wonder what God's will is for the future of our church. Together we wonder; how can we use the abundance and blessings, (what we do have and opportunities in front of us), to make a difference in Jesus' name.

### Bishop'sChristmas Message

Now in that same region there were shepherds living in the fields, keeping watch over their flock by night. Then an angel of the Lord stood before them, and the glory of the Lord shone around them, and they were terrified. But the angel said to them, "Do not be afraid. Luke 2:8-10a

Shepherds living in the fields watched over their sheep to keep them safe. There were dangers that kept the shepherds up at night and plenty of things for the shepherd's to worry about in the cold night like wild animals, predators, thieves, & bad weather. There was so much to worry about, but one night an angel of the Lord, all shiny and bright appeared and transformed their fears and worldly worry to divine wonder.

To you is born this day in the city of David a Savior, who is the Messiah the Lord. This will be a sign for you: you will find a child wrapped in bands of cloth and lying in a manger." And suddenly there was with the angel a multitude of the heavenly host, praising God and saying, "Glory to God in the highest heaven, and on earth peace among those whom he favors!" Luke 2:11-14

Friends, you are precious, beloved, baptized children of God. We know that the antidote to worry is to trust in God.

During this Advent, Christmas and Epiphany season I pray that your worries will be transformed to wonder at what God **is** doing and promises **to** do in your lives and in our churches. ### It's that Advent Time of Year by Carol Lekies

Advent, the four Sundays before Christmas, is the beginning of the church year when we focus on the birth of Jesus. It is a time to slow down, reflect, and reach out to others in need. It's a time to bring families together and attend Advent worship services.

During this time of transition, Our Saviour's will not be hosting mid-week Advent services. Not to worry, Pastor Nancy Amacher from St. Paul's Lutheran, Medford, has graciously invited Our Saviour's to join them for Wednesday evening Advent worship. Worship is at 6pm. See schedule below.

> December 7—Saint Nicholas—Is he the same as Santa Claus? What's the story? December 14—Whose Birthday Is It?— Come and celebrate a very special birthday. December 21—Caroling. What is the background of caroling? Sharing the story of Jesus in song.

Symbolizing the season is the Advent Wreath with 4 outer candles and a center candle. The first candle represents hope, the



second love, followed by joy and peace. The white candle in the center is the Christ's candle and is lit on Christmas Eve or Christmas Day.

Do you read Advent daily devotions? I do. At home, I have a simple Advent wreath. I light it in the morning and start my day with an Advent devotion and a cup of coffee. If you would like an Advent devotional they are available at church.

Maybe your family and friends go Christmas Caroling, or ring bells for the Salvation

#### CALL TO ORDER

Opened the meeting with call to order and opening prayer by Pastor Bob Giese. Meeting started at 9:10 am.

### AGENDA APPROVAL

Barb Krug added to New Business: Holy Conversations and Council Representation.

Motion to approve the agenda with those two additions by Mike Kesling, second by Ken Nernberger, motion carried.

### ESTABLISH A QUORUM (25 people)

Over 25 voting members in attendance so the quorum was met.

# MINUTES FROM NOVEMBER 2021 ANNUAL MEETING HELD 11/14/21

Motion to approve 2021 annual meeting minutes with no changes by Ed Rowe, second by Marian Nernberger, motion carried.

#### REPORTS

Pastoral Acts Report, President's Report, Worship, Education & Youth, Property, WELCA, Memorial Fund, Holway Lutheran Cemetery. No discussion on any of the reports as printed in the annual report. Motion to accept and approve all of the reports from Pastoral Acts through Holway Cemetery report made by Ed Rowe, second by Mike Kesling. Motion carried.

#### **Financial Reports:**

**2023 Joint Budget:** Brenda Nernberger, Treasurer reviewed the proposed 2023 Joint Budget. She explained that both Our Saviour's and Trinity kept the joint budget the same for salary and benefits as if we had a full-time pastor in case we do call a new pastor in the upcoming year. Ed Rowe asked about how the payment for supply pastors will work? Brenda explained if the supply pastor leads worship at both Our Saviour's and Trinity on a Sunday, the joint account would pay that pastor for their service

including mileage. If the pastor just leads worship at Our Saviour's, then Our Saviour's would pay for it under our supply pastor line in the church budget. Motion to approve 2023 Joint Budget made by Mike Kesling, second by Gordy Lekies, motion carried.

**2023 Our Saviour's Budget:** Nancie Adams, Financial Secretary reviewed the proposed 2023 Our Saviour's Budget as presented to the congregation by the Church Council. Barb noted we have been borrowing from the music fund in order to pay monthly expenses instead of borrowing or having a line of credit with interest from a financial institution. Barb encouraged more stewardship and continued giving in order to increase our funds to pay expenses and build that music fund back up. Motion to approve 2023 Our Saviour's Budget made by Ed Rowe, second by Gordy Lekies, motion carried.

### New business:

**2023 Budget** (already approved earlier in meeting) a. Pastor Search Committee / Holy Conversations: b. Mike Lindau gave an update on the call process, recent council meetings and Holy Conversations with St. Paul's in Medford. Mike gave a recap of the Joint Council Meeting with Trinity Lutheran held in October with synod representative Pastor Randy Olson. Pastor Olson went through the steps in the call process and explained there are over 20 pastor vacancies with our synod so there are many other churches in need of a pastor. Our Saviour's council is having discussions with St. Paul's in Medford about possible shared ministry and sharing of pastor as St. Paul's is also looking to call a new pastor. St. Paul's would be a good fit geographically with our congregation as it is much closer than Trinity in Unity and both churches have already done shared ministries with youth events, community services. Had the first meeting with both St. Paul's and Our Saviour's council members on November 9 with synod representative Pastor Erin Nelson leading the meeting. Was a good meeting and plan to have additional meetings and discussions in the coming weeks. Anyone is welcome to attend these meetings to offer their input and ask questions. Trinity is aware we are having these discussions with St. Paul's. Contract between

Our Saviour's and Trinity requires at least 90 days notice if either church wishes to end the partnership of sharing a pastor.

c. Council Representation: Barb Krug asked for more church members to attend council meetings to get more representation, ideas, and input from members. Also looking to get youth to attend council meetings for their input and ideas.

c. Constitutional Changes: Motion to update the Our Saviour's Constitution to include the changes as adopted by the ELCA Churchwide Assembly in their most recent model constitution for congregations made by Ken Nernberger, second by Mike Kesling, motion carried. Carol Lekies will update our constitution with those changes.

### ELECTIONS

**Election of council officers for 2023:** Barb Krug willing to continue to serve as President, Mike Kesling willing to continue to serve as Vice President, Mike Lindau has declined to run for council secretary. These are I year terms. Gayle Hamann is willing to serve as council secretary. No other candidates for any of the positions. Motion to close the nominations made by Heidi Kesling, second by Janet Cypher, motion carried. Motion to accept the nominations as follows: Barb Krug-President, Mike Kesling-Vice President, Gayle Hamann-Secretary made by Gordy Lekies, second by Pete Jaslowski, motion carried.

**Synod Assembly Delegates:** I male and I female from our congregation may attend the 2023 Synod Assembly being held on Saturday, April 29, 2023 at Bethany Lutheran Church in Rice Lake. No one has volunteered at this time so the council will work on finding representatives.

**Endowment Committee:** motion to leave Endowment Committee members as is by Karen Frosch, second by Harry Frosch, motion carried.

A motion to adjourn the meeting was made by Ed Rowe, second by Gordy Lekies, motion carried. Time of adjournment: 9:40 am
