A message from Pastor Bob



Members and Friends of St. Paul's Lutheran & Our Saviour's Lutheran

It has been my honor and privilege to be the administrative interim pastor for Our Saviour's and St. Paul's this past year. Leading worship and attending meetings and visiting some people have been a good experience.

However, beginning January 1, 2024, Synodically Authorized Minister Barb Krug will be taking over the duties of administrative interim, adding those to her duties as SAM for our two congregations.

First I discussed this possibility with Barb, who was enthusiastic about the idea. Then I got approval from Pastor Randy Olson, the Synod staff member in charge of such things. Finally, the Joint Council approved the plan at their December meeting.

Here were my main reasons for suggesting this change:

- I believe Barb will be good at it better than I am.
- I wish to concentrate my retirement pastoral efforts on my work with SAMs - teaching, listening, mentoring. There are now over 30 SAMs in our Synod.
- I need to return to being more retired than I have been for much of this year so I can spend more quality time with Jo, whose heart and mobility health issues continue to be challenging.

This does not mean you won't see me anymore. I will continue to lead worship at both congregations about once per month as needed and available. I will also be available to the councils to answer questions and give advice as requested. And I'll continue playing the piano for worship at Our Saviour's.

I've been excited to see what seems to be growing excitement about the future at both congregations since the two congregations started an official relationship last spring. It may be a bit frustrating that there's no sign of an ordained pastor in the near future, but I trust the Holy Spirit is guiding the congregations forward and has great things in store if we continue to work together to share the Good News of Jesus and God's Love with each other and our community. It's clear to me that current leadership is perfectly capable of guiding us forward in worship and ministry.

Council Meeting Minutes - December 14, 2023

Pastor Bob opened us with prayer and the group recited the mission statement. Motion to approve agenda as printed made by Mike and seconded by Brenda. Motion to approve the November meeting minutes as printed made by Brenda and seconded by Jason.

Treasurer's Report for November explained by Nancie to new members. Septic tanks had to be emptied twice in the last couple of months but unsure why or what would have caused this need. Potential to need to be looked at in future. Motion to approve the treasurer's report as printed made by Paula and seconded by Brenda. Joint Report had no major updates/changes outside of normal costs

Co-Mission Reports

New representatives to coordinate with the new council members. Sunday School/Confirmation Christmas Program is set for Dec 17 at 8AM

Meagan presented Confirmation class updates

First half of year was focused on Old Testament and second half will be New Testament. There are currently 14 students going through class. Scholarships for Bible Camp for the students

Property updates

Taylor Electric has done installations and we are waiting on a bill. Air Conditioning unit was approved by congregation at last annual meeting up to \$6000. Reviewed the bids, and eliminated Zenners, Kramer submitted a bid for \$6040 approx, Wojcik provided two different bids for two systems \$4950 and \$6250, and Neubauer quoted \$5000. Suggested to go either Neubauer and Kramer. Jason made a motion to go with Neubauer and seconded by Josh to install. Motion carried. There is a member of the congregation that is looking to donate funds to the installation of the air conditioner.

There are additional funds in the Memorial Funds that could be utilized potentially for the air conditioner or the next needed updates. Motion for using Memorial Funds to purchase and install the air conditioning unit made by Mike and seconded by Jason. Motion carried.

Driveway Sealant is suggested to be reviewed and potentially updated. Two bids were received, one by Petersen at \$6365 with a 10% discount until May 31 and the other by Jensen at \$7694. Motion to go with Petersen for the sealant made by Nancie and seconded by Andrew. Motion carries. There is \$4000 in undesignated funds and would check with WELCA for potential funds. Motion to use undesignated funds, ask WELCA for donation, and use budget made by Andrew and seconded by Lynette. Motion carries.
