- 1. **Call to order and Roll Call:** President Bob Dahm called the virtual meeting to order at 1:00 pm. Other board members present electronically were: Mike Banks, Sandy Bird, Scott Chancellor, John Coleman and Dick Davis. Cadden Manager, Tricia Beeler and 5 homeowners were also present electronically.
- 2. **Approve Minutes:** The minutes of July 10, 2020 were approved and placed on record. No meetings were held in August and September.
- 3. **Financial Report:** Mike Banks: As of September 30, 2020.

- 4. **Landscape Committee:** Scott Chancellor:
 - A. **Median:** After discussing the next phase of the Median Landscape Project, a motion was made and seconded to "**Accept Points West proposal, adjusting the rock to 50 ton, for a bid of \$14,750."** The motion carried 4 to 2. Scott will request a new document from Points West, showing the reduction of rock and adjusted bid price.
 - B. **San Miguel Drainage Issue:** Following WLB's plan to correct the erosion of a retaining wall in the wash behind San Miguel, a motion was made and seconded to "**Complete the project as required with Points West's bid of \$2,250.**" The motion carried unanimously.
 - C. Ventura/Las Campanas Basin Outlet: Major clean-out is needed on the association's side of the Ventura Basin Outlet. A motion was made and seconded to "Complete the work as per Valscape's bid of \$1,800, plus a possible addition of not more than \$100 for the delay to get approval". The motion carried unanimously.
 - D. **Tree Trimming:** Monstrosity Landscaping will start annual pruning soon.
 - E. **Plants in Monument Areas:** Scott made adjustments to the watering system for additional watering during the summer months. The watering cycle will be reduced again for the winter months.

- 5. **Nomination Committee:** John Coleman: There are 3, 2-year term positions and 1, 1-year term position to be filled in 2021. John, the committee chair, will direct all interested people to submit a "Self-Nomination Form" for the election in February.
- 6. **Website:** Scott Chancellor: A motion was made and seconded to "**Update our website to a** '**web-based' website**". Scott explained the estimated cost is about \$431.00 for 3 years, but we will also get a credit of approximately \$160.00. The motion carried unanimously. You may see the style at mrgreenvalley.com. Sandy Bird volunteered to help with the website.

7. Announcements:

- A. Mike Banks announced that October 27th is the meeting for planning the 2021 Budget. He will notify the committee with the start time.
- B. Scott Chancellor announced that the time and date for decorating the monuments for Christmas will be given at the November meeting.
- C. The next Board meeting is November 13, 2020 and will be held electronically.
- 8. **Adjourn:** A motion to adjourn was seconded and approved by all at 2:04pm.
