A. Landscape and Maintenance: Scott Chancellor

- 1) Plant Replacement on Desert Bell Several plants will be replaced when monsoon starts by Points West at LCCA expense.
- 2) **Lighting Along Desert Bell** Replaced every light along Desert Bell with soft light bulbs using 6-7 watts of energy. We expect cost savings over the previous bulbs. Scott will call Bill Richards Electric to see if he will switch to quarterly inspections, while being on call for

- emergencies. Ant damage will be the next issue. Scott will bring suggestions to the next Board meeting.
- 3) **Gravel Replacement** Bid has been received to add gravel on Desert Bell. Will be addressed in the future. A motion to *"approve the Valscape Bid for \$5,510, subject to correction,"* was made, seconded and unanimously approved.
- 4) Maintenance Irrigation checkups have been made prior to monsoon season.
- 5) **Firewise Program** Paul contacted CERT for more information. An assessment may be requested by LCCA for the entire LCCA community. An Action Plan would then be prepared. Volunteers would be needed for an ad hoc committee. CERT is available for a presentation at a Board Meeting. GVC may provide funds to assist and coordinate this effort. Scott will contact Declarant to see if they are/would be involved. GVC has more information available on this subject.

- Pima County Flood Control told an LCCA HOA President that certain vegetation up to 30 feet from a house may be removed with LCCA approval. The removed vegetation should be chipped and the chips spread in the same area. Maps were prepared to show exact areas for action and measurement. More maps will be provided at the next meeting.
