A. Landscape and Maintenance: Scott Chancellor

- 1) **Desert Bell Maintenance/Plant Replacement on Desert Bell** Several plants will be replaced, when monsoon starts, by Points West at LCCA expense.
- 2) **Desert Bell Lighting** The replacement of all bulbs seems to have been a success. Bill Richards has been set for quarterly inspections. Ant damage may be the next issue after any heavy rains. We will watch for photo cell failures and wiring issues.

- 3) **Approved Bid for Gravel Replacement** Valscape is working on proper color matching for new gravel. Work is expected to be completed this month.
- 4) **Firewise Program** The Landscape Committee recommends that efforts in this area be left up to individual HOA's.
- 5) **Approval of Pruning Application behind home site** DMR requesting approval of fallen tree branch leaning on retaining wall was approved unanimously.

6. Unfinished Business:

- Paul provided and discussed an excellent resource document from Pima County Flood Control entitled, "Guidelines for the Maintenance of Regulated Riparian Habitat."
- A copy of the recorded document, "Regulation of Public Roadways" was added to the LCCA website under Governing Documents.

- A motion was made to send a letter to a homeowner in Sonoma requesting cleanup of cut trees behind their property. The motion was seconded and unanimously approved.
- New trees will be added on Desert Bell and river rock will be added to medians.
